Attention Foreign Exhibitors

Please note that fees are due and payable in Canadian dollars. Due to consistently
fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will
be accepted, however, they are to be payable in Canadian funds. If you send a cheque in
US funds, it must be made out for the full amount of the entry and no exchange will be
refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At
Par". They will not be cleared by the banks. To simplify the process, we urge that you use
VISA or purchase bank drafts or money orders payable in Canadian funds. Your
understanding and cooperation is appreciated.

OFFICIAL CLASSES

CONFORMATION classes include Junior Puppy, Senior Puppy, 12 – 18 Months, Canadian Bred, Bred by Exhibitor, Open and Specials Only.

Entries each day are limited to 175 competitors per show.

Puppies 3 to 6 Months: Exhibitors may enter up to 2 dogs in 3 to 6 months Exhibition Only class. Limit of 30 dogs in this class. Note that the **OWNER** must also have a dog entered in one of the regular official classes each day a puppy is entered.

OBEDIENCE classes include Utility, Open A & B, Novice A, B & C, Novice Intermediate & Pre-Novice.

OFFICIAL JUNIOR HANDLING in Conformation will be judged on Saturday only. Rosettes will be awarded for first four placings in the pee wee, junior, intermediate and senior classes. Entry fee \$2.00.
