## FYI

- Bitches in season will not be eligible to compete and are not allowed on the test grounds.
- Ducks, pheasants, chukars and/or pigeons will be used.
- Rosettes will be awarded to all dogs who pass the test.
- A draw for running order will be held at the home of the Test Secretary.
- It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
- By attending this test, competitors and spectators acknowledge that The British Columbia Labrador Retriever Club Society, test officials and landowners involved do not accept liability for any loss, damage or injury incurred by exhibitors, dogs or spectators.
- **Please note the CKC ruling: Canadian Resident non-CKC members running a wholly owned dog cannot win a placement unless they pay a non-member participation fee or a membership fee to the CKC. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.**
