GENERAL INFORMATION AND TEST RULES

ELIGIBILITY: Purebred or mixed-breed dogs must be at least 12 months of age that:

- (a) Are individually registered with the CKC (have a CKC registration number),
- (b) Have an Event Registration Number (ERN),
- (c) Have a Performance Event Number (PEN),
- (d) Are eligible for registration with the CKC, or
- (e) Have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed
- (f) Have a Canine Companion number (CCN) if it is a mixed-breed

BITCHES IN SEASON: Bitches in season shall not be eligible to enter the test.

If all three components on entered electronically for the same dog, same class the fee is reduced to \$25. when the payment is processed.

TEST SITE: There will be limited indoor kennelling. No exercise pens except for giant breeds. No Grooming. Social distancing and wearing a mask that covers the nose and mouth are mandatory on the property except with your own vehicle. No exceptions. You are welcome to bring a chair. Exercising of dogs only in the Corral NW of main entrance.

Portable toilet is available. Please bring your own lunch or pick up in Aldergrove. There is a Tim Hortons and Paz fuels which has hot lunches (about 2 minutes South by car).

REGULATIONS: It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the CKC Scent Detection www.ckc.ca under forms.

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Match Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

SCHEDULE will be sent out on Saturday afternoon November 7, 2020. Day of trial is allowed if time and number permit. This will be indicated on the judging schedule. It will also be post on canuckdogs.com

- 🗣️ The club reserves the right to remove any person(s) from the show and the show grounds. The Show Superintendent shall have full control of these shows and trials, which are governed by CANADIAN KENNEL CLUB (CKC) rules.
- 🗣️ Any person excused by the Show Superintendent or Veterinarian for any reason shall not, compete in any class for any awards for the balance of the shows, trials and or events.
- 🗣️ The Trial committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident or misfortune to either dogs, exhibitors, spectators or vendors.
- 🗣️ Exhibitors may be asked by the show superintendent for proof of third party liability insurance. Failure to produce may result in dismissal from the show grounds.
- 🗣️ Dogs must be on the grounds 30 minutes hour prior to the judging of their class.
- 🗣️ The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog regardless of how or by whom the entry was made.
- 🗣️ Exhibitors and handlers will be responsible for their dogs and equipment at the trial grounds.
- 🗣️ No overnight recreational units permitted
- 🗣️ If, because of civil disturbance or other acts beyond the control of the club, it is impossible to open or complete the show, there is no refund of entry.
- 🗣️ Dogs must be on leash at all times on the show grounds with the exception of the designated detection area.
- 🗣️ Exhibitors are expected to maintain a clean area. Please be considerate when utilizing any facilities. No dogs are permitted in the washrooms.
- 🗣️ The welfare of any children is deemed to be the responsibility of the guardian or parent. Please exercise control and restraint over your child's behaviour.
- 🗣️ The club is not responsible for lost or stolen property from exhibitors or vendors/concessions. Check for lost property at the security desk. The club reserves the right to refuse an individuals entries, for just cause.
- 🗣️ The club reserves the right of restricting exhibitors space.
- 🗣️ Fire lanes in all areas will be maintained.
- 🗣️ All exhibitors must follow direction by Cotonfield Dog Centre owners.
- 🗣️ Please park neatly.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
