Directions to Tucker Creek Farm

From Thunder bay, head south on Highway 61 towards the US border. We are located at 3020 hwy 61, just past the Thunder Bay Correctional Centre. We are the first driveway on the right hand side after GFL Canada. If you have reached DeBruins Nursery, you have missed the driveway. (We are directly across from the highway from DeBruins Nursery)

From the US border, heading north on Highway 61 towards the city of Thunder Bay, we are approximately 45kms from the border. We are the first driveway on the left on the highway past DeBruins Nursery. If you see the Thunder Bay Correctional Centre, you have gone too far.

Please park in the designated parking area. We ask that you pick up after your dogs including in fields and all designated walking areas and put the bags in the garbage cans provided. Be sure to bring clothing and things for the weather such as rubber boots and rain gear, baggies, shade, and water for your dogs. There are no trees near the arenas.

TCN Fees

A CKC TCN fee of \$10.50 (GST Incl.) Canadian or US per dog per trial is payable with the entry fee if the entry of the dog does not include a CKC individual Registration number, ERN (Event Registration Number). The Temporary Competition Number MUST be obtained from the CKC prior to entering any CKC event. TCN's will replace the previous system of entering events with dogs as "listed" and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN). If a CKC registration number is received after the closing date but prior to the date of the show, this number may be added to the entry and noted in the marked catalogue. TCN fees will not be refunded.

RULES

1. The Canadian National Australian Shepherd Association, Tucker Creek Farm, organizers will use care and diligence for the welfare of all dogs and exhibitors, but will not be responsible for, nor assume liability in the event of an accident or misfortune, however caused, to either dogs, exhibitors or property. Dogs must be kept under control at all times, and must be kept on leash except when competing.
2. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a Herding Trial held under these regulations is not subject to indignities of any kind. The Herding Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.
3. The CKC shall not be responsible to any member, person, partnership, club or corporation for any loss, damage or injury arising at or by reason of any herding trial held under any rules adopted by the CKC.
4. Only dogs entered in these trials (stockdogs accepted) will be allowed within the precincts of the trial.
5. The precincts of the trial will be from the road to the barn and from the house to and including the test/trial field.
6. Exhibitors will be responsible for picking up after their dogs.
7. Water will be available for dogs to cool off in or drink
8. There is limited shade. There are no restaurants closer than 5 km from the site and food will not be available on site. Exhibitors are advised to bring their own shade, crates, food etc.
9. Exhibitors must sign the waiver form before being allowed to compete.
10. Maximum time allowed for each run will be set by the course director and announced at the handlers' meeting. The course design for each class will be decided upon by the course Director, approved by the judge and posted one hour before the start of the trial.
11. Events will be held rain or shine with the exception of lightning. Dress for the weather.
12. Exhibitors are solely responsible for the conduct or actions of their dogs while they are on the trial grounds. All dogs must be kept on leash or in crates except when competing.
13. STOCK: Test/Trial runs will use 3-5 head of sheep/ducks.

RELEASE/WAIVER AGREEMENT

In consideration for participation in these events sanctioned by the Canadian Kennel Club (CKC), I agree to assume all responsibility for any claim, loss or damage, of whatever kind or nature, whether to person or property, which may be caused at or near this event, either directly or indirectly, by me or the dog or dogs I have entered in or brought to this event. I agree to indemnify the CKC, its officers, directors, agents and members, the trial giving club, its officers, directors, agents and members and the owners of the trial facility and the stock, for any loss, cost or expense including attorneys fees and costs, to which the CKC, its officers, directors, agents or members, the trial giving club, its officers, directors, agents and members and the owners of the facility and the stock, might be subject to as a result of any claim, suit, loss or damage caused in any way by any act or negligence on my part or on the part of any dog or dogs I have entered in or brought to the event. I acknowledge that while the CKC may provide sanctioning for this event, it does not have and does not exercise control over the conduct of the event or those present. I certify and represent that the dog or dogs I have entered in or brought to this event is/are not a hazard to other dogs, other animals, or to people. I also agree to pay the full market value (\$350.00 for sheep and \$45.00 for ducks and \$1200 for cows), of any livestock death resulting from my dog's actions, whether willful or accidental, or in the case of injury to any livestock, resulting from the dog's actions, I agree to pay all veterinary fees up to the market value of the animal.
