The person making the entry shall be notified of his position on the alternate list.

Entries must be mailed or sent by courier to the postal address of the Test Secretary. Faxed, e-mailed or hand delivered entries are not acceptable. Each entry must be mailed in a separate envelope. Fees are payable to: River Valley Obedience and Field Trial Club. Post-dated cheques will not be accepted. NSF Cheques will be considered non-payment of entry fees. Please note that fees are due and payable in Canadian dollars. Bank drafts or INTERNATIONAL money orders payable in Canadian funds are acceptable. Your understanding and cooperation is appreciated.

Withdrawals and Entry Fee Refunds - If an entry withdraws between the closing date and the test date *and is replaced by an alternate*, the entry fee will be refunded. Withdrawals must be made in writing to the Test Secretary.

CKC rules (6.6.1): Entries will be refunded within 10 days of the tracking test to those on the alternate list who did not participate in the test. If an entrant pulls out of the test and is filled by an alternate who accepts the position, then the alternate is now responsible for the entry fee paid to the club. The original participant will be refunded the entry fee in full. If the alternate pulls out after accepting the position, after the closing date, and there are no additional alternates, then this alternate forfeits the entry fee to the club.

Entry fees will not be refunded if a dog is absent, disqualified, excused by a Judge, or barred from competition by action of the Test Committee.

Bitches in Season - Bitches in season **will** be allowed to participate but must run last and must be kept separated from all other dogs during the event. *You must advise the Test Secretary before the draw if your bitch is in season.*

NOTE An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be canceled. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

RVO will use all reasonable care to ensure the safety of dogs and persons at the test. However neither RVO nor any individual will accept the responsibility for loss or injury, however caused, to any dog, person or property.

CKC Tracking Rules (14.7): It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue
