GENERAL INFORMATION

- 1. All times mentioned are local times.
- 2. On the day of these events the Show/Trial Superintendent will be in complete charge of the events which will be governed by the CKC rules.
- 3. Identification cards (receipts) must be presented at the entrance to the event premises, and only dogs properly entered in the CKC licensed events will be admitted.
- 4. The building will be open 1 hour prior to the start of judging each day.
- 5. Dogs may be removed from the building when not required for further judging.
- 6. Dogs may not be left in the building overnight.
- 7. The event grounds are defined as the exterior walls of The Recreation Centre, Buckmaster's Circle, St. John's, NL.
- 8. Judging will proceed without any dog which is not present when called by the ring steward.
- 9. The Show/Trial Committee will use due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability in the event of, an accident or other misfortune to either dogs or patrons.
- 10. No person participating in any capacity at a Dog Show/Trial or Rally Trial under CKC rules shall be subjected to an indignity of any kind during the progress of the event and it is the duty and obligation of the club holding the show to see that this rule is effectively carried out.
- 11. If, because of riot, civil disturbance, or other acts beyond the control of the management, it is impossible to open or complete the show or trial, no refund of entry fees will be made.
- 12. The authorities of the show/trial may refuse to receive or may remove any dog from the show/trial building on account of disease or viciousness.
- 13. St. John's City "Stoop and Scoop" Law requires that all animal waste must be cleaned up and be disposed of properly. Failure to adhere to this law may result in fines up to \$1,000.00 levied against the owner/handler of the animal. All exhibitors are reminded that it is their responsibility to clean up after their own animals, inside the building and especially outside.
- 14. SMOKING IS PERMITTED IN DESIGNATED AREAS ONLY.
