CLOSING DATE: Entries must be received to the Test Secretary by the closing date. The Club cannot accept entries received after this date and time. After the closing date, the Club will send out acceptance letters, advising entrants of the status of their entries.

## LIMIT OF ENTRIES

6 Tracking Dog Tests (TD) 3 Tracking Dog Excellent Tests (TDX)

All entries will be acknowledged by mail/email and accompanied by a map. When the advertised limit has been reached, all remaining entries received prior to the closing date shall be assigned a position on an "Alternate List" in the order received. Entries from the Alternate List may fill any absentee spaces up until one hour before the start of the Tracking Test. The person making the entry shall be notified of their position on the alternate list. Entries will be refunded within ten (10) days of the Tracking Test to those on the Alternate List who did not participate in the Test.

## ATTENTION USA EXHIBITORS

If the dog is foreign born and foreign owned and enters Canada for the sole purpose of entering CKC events, it may be entered at a tracking test with an Event Registration Number (ERN). Such number must be applied for within 30 days of the test. Failure to do so will result in the cancellation of all awards and prizes. \*\*NEW\*\* An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member pawill have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. These fees apply to dogs wholly owned by non-members.
