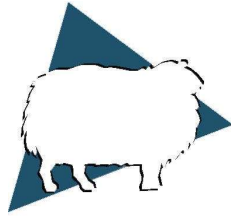

## Trial Guidelines

Exhibitors will enter the venue at the front door where they will check in and collect their armband. This is the only Entrance that will be used during the Trials. The side entrance will be closed.

Masks are not mandatory but please consider others if you are not normally in their company and keep your distance. Hand Sanitizer will be available throughout the venue.

Crating will be available in the large room connected to the front lobby. All dogs must be under control on a leash except during the test. Exhibitors may gather there before and after their searches.

The MG7 Club respectfully asks “hide” information not be shared with other competitors and that no posting of testing be placed on social media until end of trial.

The only dog permitted in trial area is dog being tested. Spectators are permitted, however, there is very little space for spectators to watch the room searches upstairs

- No food or drink (Water Only) in the Trialing area (blue floor)
- No smoking on the premises
- Only parking on the side of the venue building and in the parking lot
- No parking past the second side door as it is not owned by Ace It
- No exercising dogs on the opposite side of the street
