### **DKC Trial Guidelines**

Exhibitors will enter the venue through the door at the front of the building where they will check in and collect their armband.

Masks are not mandatory but please consider others if you are not normally in their company and keep your distance. Hand Sanitizer will be available throughout the venue.

All dogs must be in control at all times and on leash except during the test.

DKC respectfully asks "hide" information not be shared with other competitors and that no posting of testing be placed on social media until the end of the trial weekend.

Exterior hide area will determine where dogs can be exercised - areas will be indicated the day of the trials. Parking of Exhibitors will be restricted in areas within the view of the exterior trial areas.

The only dog permitted in the trial area is the dog being tested.
