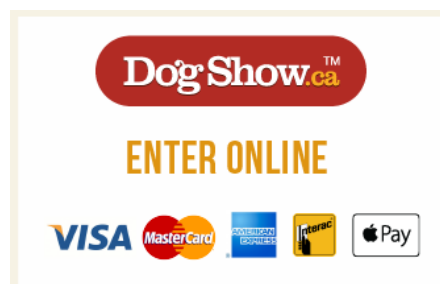

Note: Due to the COVID-19 pandemic, any public health restrictions for travel and social gatherings at the time of the event will dictate available spaces and/or cancellation of the event. All participants must sign the LOC COVID Waiver prior to participation in the event. Failure to do so will result in forfeiture of your participation and entry fee. Masks must be worn over nose and mouth.

To minimize the number of people on site only a single dog / handler per entry will be allowed.

Entries must be made through www.dogshow.ca. Only those entries submitted in the following manner and received before the closing date will be accepted. All fees in Canadian Funds

Entries are limited to 6.5 hours of judging. A waiting list will be compiled once the entry limit has been reached.

Running order is by random draw within each class. A handler may enter a maximum of two dogs.

When your entry is approved, a letter will be sent to you regarding COVID-19 rules that the LOC will be implementing. You will also receive a waiver which must be completed and submitted on the day of the trial.

REFUNDS

Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

COVID-19 Refunds will be given if the trial is cancelled due to COVID-19 restrictions or if an exhibitor provides confirmation of their COVID-19 positive test within 14 days of the trial date.
