## \*\*\* JUDGE CHANGE for SWEEPSTAKES \*\*\*

Unfortunately, our Sweepstakes Judge, Marcel Nussbaumer, is unable to fulfil his judging duties. Fortunately, Ed Molloy has kindly agreed to take over this assignment.

This rule applies for all sweepstakes entries. CKC RULE 3.3.1 "... Exhibitors affected by this change may withdraw their entries up to one (1) hour before the JUDGING OF THE BREED, notice of withdrawal must be made in writing. All entry and listing fees for withdrawn dogs shall be refunded. An exhibitor may enter a dog under the replacement judge providing that the dog is entered in one (1) of the regular classes of a show being held at the same venue by the same club and has been assigned a competition number. A new entry, along with accompanying fees, will be accepted by the Show Secretary up to one (1) hour prior to the START OF THE SHOW."
