September 2021 Trial Ring Traffic Flow – COVID-19

MASKS MUST BE WORN INSIDE THE BUILDING.

- Upon arrival, exhibitors are to show their Covid-19 Vaccination Card or Proof of Vaccination together with ID, at the **rear door of the building**.
- Exhibitors may then proceed to the check in desk, located inside the building **rear door**, hand in their signed waiver form, and pick up their armband.
- Exhibitors for each class being judged are to gather in the assembly area inside the building **front door**, or outside the **front door** until the **Gate Steward** calls their armband numbers.
 - 1) First dog/handler proceeds to the “on deck” area, to QUIETLY wait to be called into the ring. Treats are allowed in this area however, containers/excess treats cannot be taken into the ring area.
 - 2) Once the prior exhibitor leaves the “on deck” area, the **Gate Steward** allows the next dog/handler to enter the area.
- When called by the **Ring Steward**, **prior to** entering the ring, exhibitors in Open and Utility and classes must place dumbbells and Utility scent articles on the indicated chair.
- Upon entry into the ring, exhibitors place their leash on the indicated chair.
- At the end of the judging, the exhibitor will pick up their items and leave the ring through the exit and promptly leave the building through the **rear door**.

Group Stays

Eligible dog/handler teams will wait outside the **rear door** until the **Ring Steward** calls them into the building. Teams line up 2 metres apart prior to entering the ring.

The **Ring Steward** will lead the teams into the ring.

At the conclusion of judging, teams will file out of the ring in the order they entered.

Announcement of scores

At the end of each level of judging, the **Gate or Ring Steward** will call qualifying teams into the building.

Teams to maintain a minimum of 2 metres physical distance.

Photos with the judge will be at discretion of the judge.
