General Information

1. The trials will be held outdoors on artificial turf. No cover will be provided in case of inclement weather.
2. Precincts of the trial include the Fetch agility field, parking lot and front lobby, office and washroom of the building. Masks are required when using the washrooms inside the Fetch Inc building.
3. There will be no indoor crating. You should come prepared to crate out of your vehicle.
4. Parking is available in the Fetch parking lot and on the street.
5. Please ensure you pick up after your dog.
6. There will be no canteen at the site however there are several restaurants and coffee shops for take out in close proximity to the trial.

8. While no governmental COVID-19 restrictions exist at the time this schedule is issued, should the situation change government regulations will be followed. If the judge requests masking during briefings and/or walk throughs, notification will be made. Please bring a mask just in case it is required.

Trial Information

1. Running order will be Novice, Intermediate, Excellent for Trials 1,2,3,4 and 5. In Trial 6 the Standard will run Excellent, Intermediate, Novice.
2. Course maps will be provided electronically before the trial.
3. Move ups are available to the next class between days or one hour before the start of the next trial on the same day by completing the required Move-up Form. Please note Move-ups are permitted for dogs with a CKC Reg, PEN, ERN, MCN or CCN numbers only
4. Participants in the trials will be required to volunteer. A volunteer schedule will be available on the Fetch Agility Trial FB page, It is important to have all hands available for the course builds so that the day finishes on time and the judge has time for a break and lunch.
5. No equipment familiarization will be offered for Novice dogs.
6. Warm-up jumps will be provided in proximity to the ring area.
