**NON-MEMBER PARTICIPATION FEE/TCN Number: The CKC requires all owners of unregistered, recognized breeds entering events to obtain a Temporary Competition Number (TCN). TCNs will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN). https://www.ckc.ca/en/News/2020/March/TCNs-What-Are-They-And-How-Do-You-Get-One If a dog is not registered individually in the records of the CKC, it may be entered at a trial held under these rules with a Temporary Competition Number (TCN), providing that the number is obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid. While there is no fee for the Temporary Competition Number, exhibitors will still be required to pay listing fees when entering events. The request for a TCN will be self-serve; exhibitors should go to the CKC website to complete an online application and a TCN will be issued instantly. Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC, or by contacting the Shows and Trials Division by telephone.

GENERAL INFORMATION • It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer, or any participant at an event is not subject to indignities. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on the receipt of a report indicating that this has occurred. (See Section 19.7)

Bitches in season - Bitches in season are eligible to compete as of January 1, 2024. Should a bitch be in season, the handler must notify the trial secretary prior to the trial date. Bitches in season will be scheduled to run last in each component and must wear clean, properly fitted panties.

Move Ups: Same day trial move-ups will not be allowed. Move-ups are available to the next level of competition at the next trial provided the CKC move-up form has been completed appropriately.

Reminder: Anyone discussing hides before the end of the class will be awarded a score of "NQ" and will be excused and asked to leave as per CKC rules.

Accessibility: Please note that access to the basement of the hotel requires the use of stairs. Search areas may utilize the stairs and stairwell areas. If, due to handler necessity, a competitor requires the use of the elevator to access the basement, or any other accommodation, kindly notify the trial secretary by entry closing to ensure we can do our best to accommodate your needs.

Test Site: Indoor benching is not available. Please be prepared to bench out of your vehicle. The trial will run rain or shine. All dogs must be under control and on leash at all times, except where off leash searches are permitted. Remember this is a private commercial hotel; dogs are not permitted inside the hotel except when conducting searches. Dogs are not to be permitted to interact with hotel staff or guests.

Washroom facilities are onsite on the main level of the hotel. Washrooms in the basement are off limits to competitors. Dogs are not permitted in washrooms except when searching.

If, due to civil disturbance or acts beyond the control of the club, it is impossible to open or complete the trials, there shall be no refund of entry.

Please allow for absentees and variances in the rate of judging.

Please obey staging directions, including entry and exit directions, in the trial area. Any competitor failing to comply with staging directions may be removed from the trial.

Please clean up after your dog. Competitors failing to pick up after their dogs will be excused from the trial. Dogs are permitted to relieve themselves ONLY on the grassy bank on the south side of the hotel, between the hotel and the McDonalds. Do not permit your dog to potty on anything manmade.

Trial Precincts – The hotel building, and exterior hotel areas, including the parking lots, courtyard, garden areas.

Volunteers – Volunteers are always needed to run trials efficiently and on time. Please contact the trial secretary if you are able to volunteer.
