EXTRACTS FROM CKC CONFORMATION SHOW RULES

CHAPTER 4.1.3 - JUDGES

A judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show, and it shall be the duty and obligation of the club holding the show to see this rule is effectively enforced.

8 - ENTRIES and ENTRY FEES

Section 3.1

Every dog entered in Championship Shows held under these rules must be registered, have an Event Registration Number, eligible for registration with the CKC or have a CKC Miscellaneous Class Certification number issued by the CKC Chief Registrar. If a dog is not registered individually in the CKC it may be entered at a show, held under these rules, as a "listed" dog, provided

(a) it is not a Miscellaneous breed

(b) if born in Canada, is eligible for individual registration

(c) if foreign born and owned, an Event Registration Number or CKC registration

number is obtained from the CKC within 30 days of the first show entered.

A listing fee of \$9.29 must accompany the entry of a "listed" dog at a show held under these rules.

Section 2.3:

INCOMPLETE ENTRIES

Entry forms which are incomplete or those that contain incorrect information after the closing date of entries will be void and under no circumstances can changes be made. Any dog taking a win resulting from such an entry will result in the wins being canceled, and persons making such changes will be subject to disciplinary action.

Section 8.2:

DISHONORED CHEQUES

Tendering of a dishonored cheque or credit card in payment of entry fees shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. Clubs may refuse to accept entries from any exhibitors who have been known to tender dishonored cheques in payment of entry fees unless such entries are accompanied by a money order or certified cheque.

CHAPTER 14 - DISQUALIFICATION

Section 1.4

A dog once disqualified for any reason at a Championship show held under these rules cannot again be shown or entered at a show held under these rules unless and until said dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be canceled by the CKC and the owner of said dog is subject to disciplinary action. Note: for any further information on reinstatement refer to Chapter 16, Section 3 of the CKC Dog Show Rules

CHAPTER 9 - EXHIBITORS and THEIR DOGS

A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.

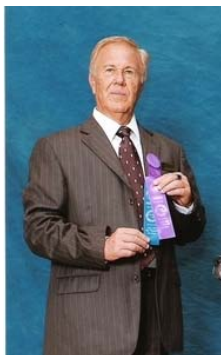

DR JOSE LUIS PAYRO

Jose Luis Payro was born in Mexico City and grew up in a family of sports minded dog fanciers. He became a Medical Veterinarian Doctor at the National University of Mexico, where he has been a teacher since 1974.

His success in breeding and showing Afghan Hounds, Great Danes, Rottweilers and Dobermans led him to create the first All-Breed Veterinarians Club in Mexico, affiliated to the Mexican Kennel Club (Federacion Canofila Mexicana) F.C.M.

Dr. Payro was approved to judge all breeds in 1975 by the Mexican Kennel Club (FCM). Since then, he has judged FCI shows all over the world, including Europe, Canada, U.S.A, Central and South America, Asia, Australia, New Zealand, Major Shows in Italy, the World Dog Shows in Argentina, Vienna, and Budapest and in his own country, Mexico

In 1975 AKC approved Dr. Payro to judge All Breeds, Groups and Best in Show with no restriction on number of shows in a year, all over the U.S. He has also been approved by CKC to judge All Breeds in Canada.

He is an active member and President of the Board of Directors of the Mexican Kennel Club; he belongs to the FCI Standard Committee and has also been a part of the Scientific Committee in the FCI..

He has received several awards in the world arena as a judge and as a veterinarian. The Mexican Medical Veterinarian Association named Dr. Payro "The Veterinarian of the Year" in 1995.

Dr Payro has his own practice in his veterinarian clinic, he has written five dogs encyclopedia, for breeders, judges, veterinarians and students, with the FCI standards.

RULES GOVERNING THESE SHOWS

1. THE CLUB RESERVES THE RIGHT TO REMOVE ANY PERSON FROM THE SHOW. THE SHOW SUPERINTENDENT SHALL HAVE FULL CONTROL OF THESE SHOWS AND TRIALS, WHICH WILL BE GOVERNED BY CKC RULES.
2. ANY DOG EXCUSED BY THE SHOW SUPERINTENDENT OR VETERINARIAN FOR ANY REASON SHALL NOT, COMPETE IN ANY CLASS FOR ANY AWARDS FOR THE BALANCE OF THE SHOW.
3. THE SHOW COMMITTEE WILL USE DUE CARE AND DILIGENCE FOR THE WELFARE OF DOGS AND EXHIBITORS, BUT WILL NOT BE RESPONSIBLE FOR, OR ASSUME ANY LIABILITY IN THE EVENT OF ACCIDENT OR MISFORTUNE TO EITHER DOGS, EXHIBITORS, SPECTATORS OR VENDORS.
4. DOGS MUST BE ON THE GROUNDS 1 HOUR PRIOR TO THE JUDGING OF THEIR BREED.
5. THE OWNER OF A DOG ENTERED IN THESE SHOWS IS ENTIRELY RESPONSIBLE FOR ANY ERROR IN ENTERING HIS/HER DOG REGARDLESS OF HOW OR BY WHOM THE ENTRY WAS MADE.
6. EXHIBITORS AND HANDLERS WILL BE RESPONSIBLE FOR THEIR DOGS AND EQUIPMENT LEFT AT THE SHOW GROUNDS.
7. DOGS ARE TO BE EXERCISED IN DESIGNATED AREAS ONLY, NOT IN VICINITY OF SHOW RINGS
8. ALL RECREATIONAL UNITS WILL HAVE BUCKETS UNDERNEATH FOR THEIR SINK DRAINS. ANYONE FOUND DISCHARGING WATER ON THE GROUNDS WILL BE REMOVED BY ORDER OF THE HEALTH DEPARTMENT, AND MAY BE SUBJECT TO A FINE.
9. IF, BECAUSE OF CIVIL DISTURBANCE OR OTHER ACTS BEYOND THE CONTROL OF THE CLUB, IT IS IMPOSSIBLE TO OPEN OR COMPLETE THE SHOW, THERE IS NO REFUND OF ENTRY.
10. DOGS MUST BE ON LEASH AT ALL TIMES ON THE SHOW GROUNDS OR WITHIN THE SHOW BUILDING.

ALL EXHIBITORS, HANDLERS AND PATRONS ARE EXPECTED TO KNOW AND ABIDE BY THE CKC DOG SHOW RULES

CHAMPIONS AND CHAMPIONSHIP POINTS

SECTION #1. A dog awarded WINNERS at a Championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION #2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows;

DOGS COMPETING*	1	2	3 to 5	6 to 9	10 to 12	13 or more
POINTS AWARDED	0	1	2	3	4	5

*includes the dog awarded Winners

To determine the number of points earned by a dog awarded Winners, total all dogs in competition which were defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best Opposite Sex and then consult the schedule set forth above. The point system provides for additional points if a class dog awarded Best of Breed also places in the group as listed below;

A class dog awarded Best in Show at an all-breed Championship show will be credited with 5 points inclusive of any points earned at the breed or group level. In counting the number of eligible dogs in competition, a dog that is disqualified or that is dismissed, excused or ordered from the ring by the judge, shall be included in the calculation for championship points (Absentees are not to be included). In order for a dog to be recognized as a Canadian Champion it must: (1) earn at least ten championship points under at least three different judges; and (2) be individually registered in the records of the CKC or have a CKC Event Registration Number (ERN)

Mr. Porter was always mad about animals from early childhood on, rabbits, chickens, dogs and cats. You name it, he had them and the collection always seemed to be growing.

His paternal grandparents were farmers and living next door to a Hunt kennels, so subsequently he also loved horses and he his own pony for many years, enjoying Hunting and Cross Country.

His involvement with Cavalier King Charles Spaniels spans over 30 years with him having purchased is first one in 1973. Like many people, he caught the "show bug" and purchased some lovely foundation bitches from the famous Kindrum kennel and a lovely Blenheim bitch that became IR CH. Ronnoc Scarlet Ribbons, a CC winner.

Mr. Porter has bred on a small scale, usually one or two litters a year at mos and some years none, but he has bred or owned some 7 Irish Champions and numerous other Green Star winners.

In recent times his showing has been very limited due to family commitments.

He first awarded Challenge Certificates in Cavaliers in 1990 at the Southern Club show and has judged a number of Breed Club shows since

Overseas he has judged in Scandinavian Countries as well as in the USA, New Zealand and Australia. He also passed by the Irish Kennel Club to judge the entire Toy Group and Group 9 under the FCI system.

My involvement with purebred dogs started in 1965 when my wife Lory and I acquired a fawn Boxer. This dog was never shown, however in the late 1960's we obtained our first Miniature Schnauzer, and after encouragement and handling classes conducted by the late Joan Morden (Tannenbaum Kennels) she was shown to her Championship going on to take a Group First at one year old. Several Mini Schnauzers quickly followed and within two years, Lory was handling Schnauzers for several other breeders and the professional handling business was launched.

My career as a "dog professional" started early in the 1970's. I was employed by Dog Show Associates Ltd. as a ring steward at shows throughout Ontario, and served as Show Superintendent/Secretary for the all-breed club of which I was a member. I was also a member of the Tri-States Ring Stewards, stewarding professionally in the United States for several years. I've belonged to several all-breed clubs over the past 40 years and currently am a member of the Caledon Kennel Association. As a member of the Professional Handlers Association in Canada, I served on the executive board as treasurer. In addition to Mini Schnauzers, I've been extensively involved in breeding and handling Airedale Terriers and German Short-haired Pointers both in Canada and the United States. I've owned and exhibited Standard Schnauzers and Siberian Huskies and have handled breeds from all groups throughout the years, always being available to take a dog in the ring when my wife encountered conflicts.

With a background in photography that goes back to my high school days, in the early 1990's I was cajoled into becoming a Dog Show Photographer, by Bill Stonham of Stonham Photography, and acquired the business shortly thereafter, photographing shows from Calgary to Quebec.

At the same time, I was interested in becoming a dog show judge. I started with the Terrier Group and then progressed to the Sporting Group and Working Group. Since then, I've judged extensively in both Canada (from coast to coast) and the United States including several National Specialties for various breeds. Currently I am approved for the Sporting, Hound, Working, Terriers, Toys and Herding groups including Best In Show.

In the year 2001, I was granted life membership in the Canadian Kennel Club as a 30 year continuous member. Although now retired from show photography and handling (you still might find me handling one of my own dogs), you'll likely find me at the shows, mentoring a future judge, observing a permit judge for the Canadian Kennel Club or just taking in the judging in process at the time, be it Westminster, Montgomery County, or the local show just around the corner.

1. Crates will be allowed at ringside during the judging of your specific breed **ONLY** and **MUST BE** removed immediately after, **NO EXCEPTIONS**.
2. There will be an area designated for the exercising of dogs. No dogs will be allowed to exercise elsewhere on the grounds. The Renaissance Dog Association asks that you pick up after your dogs. Offenders may lose show privileges.
3. Using the building facilities is a privilege, please be considerate. Dogs are not allowed in the washrooms.
4. The Welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that you will exercise control and restraint over the children in your care on the days of these shows.
5. The Club is not responsible for lost or stolen property from exhibitors or vendors/concessions.
6. The Club reserves the right to refuse an individual's entries, for just cause
7. Delays waiting for dogs are not possible and handlers with several breeds **MUST** arrange for alternate handlers if judging times for their dogs' conflict.
8. The Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident or misfortune to either dogs, exhibitors, spectators or vendors. (See 'AGREEMENT' on the back of the entry form)
9. The Club reserves the right of restricting exhibitors grooming space
10. Heritage Park is a **NON SMOKING** facility, there are no exceptions. If you wish to smoke, please do it outdoors. Fire Lanes must be kept open everywhere. Please be considerate and think defensively.
11. **PLASTIC** sheeting **MUST** be under **ALL EXPENS**
12. **Any tape used in the building has to be easily removable and must be removed after the show is completed. COLORED TAPE IS NOT ALLOWED.** You must leave your setup in the same clean condition you found it in when you first arrived at the show.
13. **EXTENSION CORDS**, if laid across an aisle **MUST** be taped down properly – think of the safety of others!
14. Aisles must be kept open at all times to allow everyone easy and speedy exit in case of emergency.
15. Unless permission is granted 'in writing' by the Renaissance Dog Association there will **NOT** be any handling classes operated or offered by anyone in any part of the Heritage Park facility at any time.

"Any videographer or photographer, other than the official videographer/photographer, that is going to take pictures for which they will be remunerated will require written permission from both the Renaissance Dog Association Show Committee and/or the official show photographer. This rule does also apply to any and all Specialty clubs holding their event in conjunction with an all-breed club (i.e. 2, 3 or 4 day duration/same venue). Ringside candid photography of your dog is available upon request at any time during the day when the club's official show photographer is available."



**IMPORTANT NOTICES
TO ALL EXHIBITORS and VENDORS
FROM THE MANAGEMENT OF HERITAGE PARK**

1) Due to the ongoing problem in the grooming area with exhibitors continuing to pour buckets of wash water into the garbage barrels, mixed with dog fecal matter and urine, makes it very unpleasant for the custodial staff as the bags are leaking and breaking open when being changed. Our resolution to this problem will be to remove the garbage barrels and place a 4 yard dumpster on the south end of the grooming area for the participants to use.

2) To the vendors – cardboard is not to be left on the floor at anytime. There is a large cardboard recycling bin located on the south end of the building between floor 1 and 2. Please ensure you that you place all cardboard in the recycling bin.

3) Parking is still a continuing problem – There is NO PARKING permitted within 6 meters of the buildings, in front of the fuel tank (east side of building), the North and South side of the storage building behind the main building, in front of the fire hydrants, in Handicapped parking (if an approved sign is not displayed) and on the south of floor 1 which is Concession Staff parking only. Effective October 30, 2006 Heritage Park will be working with a local towing company to patrol the lot and will have vehicles removed that are in violation of the no parking areas.

In consideration of the acceptance of this entry and of the holding of the Show and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Renaissance Dog Association, their members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
