**Note: Obedience Trial on FRIDAY ONLY will commence some time after 4PM. Time to be determined after closing.**

**OBEDIENCE CLASSES:**

No dog may be entered in both Novice "A" and Novice "B", Open "A" and Open "B" at the same trial. In determining class eligibility, if a dog shall have won a particular title before being entered or moved up, the handler shall have been notified by at least 2 different judges that the dog has won 3 qualifying scores for the required title. (However, a dog may continue to be exhibited for 60 days in a class after winning a particular title.)

Dogs fulfilling the requirements for a title may be moved to the next level of competition if the schedule permits. The transfer must be on the appropriate move-up form and submitted to the show secretary at least 15 minutes before the start of the class.

**PRE-NOVICE** - The Pre-Novice class is an elective class and earning the title is not a requirement to enter Novice classes. The Pre-Novice class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of P.C.D. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 5 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercise. Only dogs that have not earned the title of C.D. may enter the Pre-Novice class.

**NOVICE A** - The Novice A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of C.D. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. No person who has trained or exhibited a dog that earned a C.D.X. title shall be allowed to handle a dog in this class.

**NOVICE B** - The Novice B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of C.D. Dogs in this class may be handled by the owner or any other person. The owner or any other person may handle a dog in this class. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises.

**NOVICE C** - The Novice C class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title C.D. or any higher obedience titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. Dogs may compete in Novice C indefinitely. Scores earned by dogs in the Novice C class are not eligible for High In Trial and do not qualify a dog for any title. Dogs may be entered in the Novice C class in addition to any other official or unofficial classes for which they are eligible.

**NOVICE INTERMEDIATE** - The Novice Intermediate class is an elective class and earning this title is not a requirement to enter the Open classes. The Novice Intermediate class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned a C.D. or any higher obedience trial titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle the dog in all 6 exercises. Dogs may compete in the Novice Intermediate class indefinitely. Scores earned by dogs competing in this class are not eligible for High in Trial. Dogs may be entered in the Novice Intermediate class in addition to any other official or unofficial classes for which they are eligible.

**OPEN HA** - The Open HA class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. but has not earned the title of C.D.X. The handler of any dog in this class must be the owner, co-owner or member of their immediate families. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. Any person who has trained or exhibited a dog that has earned a U.D. title may not handle a dog in this class.

**Open18A** -The requirements are the same as Open HA and the same rules except the Long Sit is replaced with Change of Positions Exercises and the Long Down is replaced with a Group Sit-Walk around.

**OPEN HB** - The Open HB class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. Dogs which have earned the title of C.D.X. or any higher titles may enter in the Open B class. A dog may also be entered in the Utility Class in the same trial. Dogs in this class may be handled by the owner or any other person. A person may enter or handle more than one dog in this class. The same handler must handle each dog in all 7 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. Prior to the start of judging, the judge will choose which of the six numbered routines is to be performed. This choice will not be disclosed to the exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each set will be used approximately the same number of times.

**Open 18B** – The requirements are the same as Open HB and the same rules except the addition of the new Change of Positions Exercises and Long Down is replaced with a Group Sit-Walk around.

**UTILITY A** - The Utility A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D.X. but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a M.O.T.Ch. title may not handle dogs in this class. The handler of any dog in this class must be the owner or member of their immediate families. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises.

**UTILITY B** - The Utility B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D.X. or U.D. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. Prior to the start of judging, the judge will choose which of the six numbered routines will be performed. This choice will not be disclosed to exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each will be used approximately the same number of times.

## **UNOFFICIAL OBEDIENCE CLASSES:**

All dogs entered in the Unofficial Classes must be entered in one of the Official Classes or Exhibition Only.

**EXHIBITION ONLY** - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class MAY NOT COMPETE in any Regular class but may enter and compete in Non-Regular classes and/or Parades ONLY

**GRADUATE NOVICE CLASS** – This class is open to any dog that has not earned a qualifying score toward the C.D.X. title, but has obtained the title of C.D. prior to the closing date of the trial in which it is to be entered. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such a case, he must have an additional handler for each extra dog when they are judged together in the group exercises. The Graduated Novice Heel on Leash and Stand for Examination exercises shall be performed and judged as in the official Novice Class. All other exercises shall be performed and judged as in the official Open Class.

**GRADUATE OPEN CLASS** – This is open to any dog that has not earned a qualifying score toward the U.D. title, but which has obtained the title of C.D.X. prior to the closing date of the trial in which it is to be entered. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such case, he must have an additional handler for each extra dog when they are judged together in the Long Sit.

**BRACE CLASS** – This is open to any 2 dogs that earned the title of C.D. or higher. The 2 dogs need not be owned by the same person but must be the same breed for a breed specialty obedience trial. The owner or any other person may handle a brace and they may enter more than one. The same handler must handle each brace in all 6 exercises unless he has 2 or more braces entered. In such case, he must have an additional handler for each extra brace when they are judged together in the group exercises. The Brace Class is performed and judged in the same manner as the Novice Class. The 2 dogs shall be hitched together with a brace chain or coupling and are judged on the performance of the 2 dogs as though they were one.

**VETERANS CLASS** – For any dog that has earned a title of C.D. or higher and is 7 years old or older on the day of the trial. The exercises shall be performed and judged as in the Novice Class. The owner or any other person may handle a dog in this class. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such case, he must have an additional handler for each extra dog when they are judged together in the group exercises.

## **RALLY CLASSES:**

No dog may be entered in both Advanced "A" and Advanced "B" at the same trial or Excellent "A" and Excellent "B" at the same trial.

**RALLY NOVICE A** - Dogs competing in this class may not have won a CKC Rally Novice (R.N.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC Companion Dog Excellent (C.D.X.) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification form the CKC that the dog has won the title.

**RALLY NOVICE B** - Any dog may compete in this class until a qualifying score in the Rally Advanced class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

**RALLY INTERMEDIATE** - This class shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dog in this class. A person may enter more than one dog in this class.

**RALLY ADVANCED A** - This class shall be for dogs that have won the Rally Novice (R.N.) title but have not won the Rally Advanced (R.A.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC Companion Dog Excellent (C.D.X.) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

**RALLY ADVANCED B** - This class shall be for dogs that have won the Rally Novice (R.N.) title. A dog completing the Rally Advanced (R.A.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. All dogs must enter and leave the ring on leash.

**RALLY EXCELLENT A** - This class shall be for dogs that have won the Rally Advanced (R.A.) title, but have not won the Rally Excellent (R.E.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC Companion Dog Excellent (C.D.X.) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this case must be the owner, the co-owner, or a member of their immediate families. A person may enter more than one dog in this class, A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class .However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

**RALLY EXCELLENT B** - This class shall be for dogs that have won the Rally Advanced (R.A.) title. A dog completing the Rally Excellent (R.E.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class, A person may enter more than one dog in this class. All exercises are judged off leash except the Honor Exercise. All dogs must enter and leave the ring on leash.

**RALLY MASTER** - This class is for dogs that have earned the RE title. Any person may handle the dog in this class. Dogs must earn 3 qualifying scores of 85 points or more under at least 2 different judges.

A **Candid Photograph** is defined as a photograph captured without creating a posed appearance. This is achieved in many ways, for example: when the subject is in motion, by avoiding prior preparation of the subject, by not distracting the subject during the process of taking photos.

### 4.7 Indignities to a Judge

4.7.1 A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be duty and obligation of the club holding the show to see that this rule is effectively carried out.

### 11 Unsportsmanlike Conduct

11.1 It shall be deemed unsportsmanlike conduct if a person during the running of or in connection with an event abuses or harasses a judge, show official or any other person present in any capacity at the event.

11.2 Any handler who displays unsportsmanlike conduct or who is seen to kick, strike or otherwise roughly manhandle a dog at any time during the holding of the event, may be expelled from the show by the Conformation Show Committee.

11.3 The judges shall also have the authority to expel a handler from a show if they observe unsportsmanlike conduct on the part of the handler or see the handler kicking, striking or otherwise roughly manhandling a dog while the event is in progress. It will be the duty of the judge to report promptly to the Conformation Show Committee the expulsion of a handler.

11.4 The Conformation Show Committee shall investigate, at once, any instance of alleged unsportsmanlike conduct on the part of the handler, or any report that a handler has been observed kicking, striking or otherwise roughly manhandling a dog. If the Conformation Show Committee, after investigation, determines that a handler is in violation of this section, and that the incident, if proven, would constitute conduct prejudicial to the sport or the CKC, it shall exercise its authority in accordance with the Complaints section of these rules.

Due to a new bylaw drafted by the District of Coldstream, the Vernon and District Kennel Club will be charged an additional \$10 per campsite per day for the rental of Lavington Community Park. The club is absorbing half of this increase, but has found it necessary to pass on one half of this increase (\$5 per site/per day) to our RV parking rates. RV Parking will now be \$35 per site per day. This additional cost is to be used to upgrade facilities of this lovely park and will hopefully ensure our continued use of the site.

### **Judge Biographies**

#### **Terry Carter:**

Terry is an all breed judge who has owned and handled Old English Sheepdogs, Chow Chows and Norfolk Terriers. Her first dog was a Smooth Fox Terrier given to her by her grandfather when she was a child. Her father had Border Collies, which were working livestock dogs and later Australian Cattle Dogs. Her involvement with dog shows and OES began with her marriage to Gary in the mid- 60's and together, under kennel name, "Some Buddy Reg'd." have bred over 100 CKC champions, approximately 40 AKC champions, a National Specialty winner in Australia, plus a dog exported to Denmark who went on to be a top producer there. Included in this are Specialty winners in the U.S. and Canada as well as about a dozen Best in Show winners. In 1977 she exhibited "Some Buddys Titled Hero" to #3 all breed and #1 Working dog. They have more recently added Norfolk Terriers to the household and have produced a number of Canadian and American champions, including an all breed BIS Winner.

Terry and her husband have maintained a small herd of Shorthorn cattle and have bred high-ranking Event horses, an interest they still follow. She has been honoured to have judged the American National and the breed at the American Centennial, the Australian National, a German National plus Specialties in other breeds. Besides the U.S. and Canada she has judged in Australia, Brazil, Japan, Ireland, Hong Kong and Germany

#### **Terry Gains:**

As a teenager I wanted a horse, my parents would only go for a dog. The dog of my choice was a black Labrador Retriever, Suzie. This started my association and love with the breed. I became involved with the sport of dog obedience and conformation shortly after.

I have trained and competed in Obedience and Conformation for the past fifty-five years. I have been lucky enough to obtain ten OTCH titles and I'm working on number eleven.

My wife and I have bred Labradors for thirty-five years using the Gainspride prefix. Gainspride Labradors have produced Specialty and Best in Show winners. We have had Miniature Pinschers. This was a new learning curve. Min Pins were not Labradors. Learning to see things from a small dog's perspective gave me new insight into both conformation and obedience.

I have been judging Obedience for twenty-seven years and Rally-O since its addition to CKC. In conformation I'm approved for six groups, Sporting, Toys, Herding, Working, Non-Sporting, Hounds and Best In Show. Presently I'm working on my permit for Terriers.

**Susan Quesnell:**

After acquiring my first Siberian Husky in 1972, the first litter of Atim Reg (perm) was whelped in 1975. My direction in this breed became sled dog racing and the education in structure and commitment to form and function followed. I continued in the conformation ring and finished many champions that also competed in racing teams.

In 1985 I added a Belgian Tervuren bitch to our household. Over the next ten years the beauty, trainability, and loyalty of the Belgian Shepherd became my focus. My breeding program with a small Tervuren kennel has produced National Specialty winners in the US and Canada, all breed BIS winners, numerous Canadian and American conformation champions, HIT obedience dogs, agility title holders and Herding Trial winners.

Not to be forgotten was my interest in Pomeranians and I have had several that completed their championships and lived out their lives as my valued companions.

**Norma Schaffer:**

I grew up with English Springer Spaniels that my father used for hunting. A family friend introduced us to the Vancouver Junior KC where I became involved with obedience training. Some years later when my husband and I were able to have a home with some space, we got a dog - a Springer, of course - and I became re-acquainted with obedience training and trialling. Then came tracking, rally, pet therapy and hunt tests and even conformation! I currently share my home with 2 Springers with whom I continue to participate in all of these activities as well as judging Obedience and Rally trials and Field Tracking tests. Whatever their score, I hope that competitors enjoy the time spent with their dog.

**Guy Spagnolo:**

Guy Spagnolo's lifelong love affair with Labrador Retrievers began when he was just nine years of age. Since that first much-loved Lab his interest in the breed has never waned – exhibiting them from the age of 16 and breeding his first litter in 1974. The rest, as they say, is history – with his Driftway Labradors sweeping all before them. From his first homebred bitch taking out Puppy in Group and then two years later Best in Group at Sydney Royal, the Driftway dogs have accounted for multiple Royal Show honors all around Australia, including Best Exhibit in Brisbane and Runner Up Best in Show at Sydney, on more than one occasion. They have also consistently tanked out the top awards at Specialty and regular All Breed shows, both under specialist judges and all-rounders. From the mid 1970's to the late 1980s Guy has also successfully exhibited English Cocker Spaniels. He has bred more than 80 Champions over the years, exporting his dogs to the United States, Canada, the Philippines, New Zealand, South America, and Japan – where many of them

have collected overseas show titles and been the top winners, both in their breeds and at All Breed level. In 1980 Guy started judging Gundogs and by 1992 had been awarded his All Breeds license. He has adjudicated at dog shows in Sweden, Finland, Denmark, Italy, the United States, Canada, New Zealand, South Africa, Japan, Argentina, Chile and Uruguay as well as throughout Australia. Guy has also judged junior showmanship on various occasions including Junior Handler classes at both Sydney and Brisbane Royals.

**Brent Wright:**

I exhibited a Boxer at my first show in 1963 when I was a youngster. Later, competing in Junior Handling I became the top Senior Boy Handler in B.C. in 1966. In 1967 I purchased a Bedlington Terrier from the U.S. and finished his Canadian and American championships myself.

Although no longer breeding or exhibiting, Bedlington Terriers were my primary breed. Only two Canadian bred Bedlingtons have ever won an all breed BIS in the U.S. and I am fortunate to have bred both of them. I am also pleased to have bred the #1 Bedlington in the U.S. and the #1 Bedlington in Canada for 2013. They were both litter mates and were owner-handled. Afghan Hounds and Doberman Pinschers were two other breeds I bred. I also owner-handled a BIS winning Doberman bitch. Collies(Rough) and German Shepherds were breeds I showed for friends. Dogs have been a passion all of my life.

A class dog awarded Best in Show at an all-breed Championship show will be credited with 5 points inclusive of any points earned at the breed or group level. In counting the number of eligible dogs in competition, a dog that is disqualified or that is dismissed, excused or ordered from the ring by the judge, **SHALL NOT** be included in the calculation for championship points (Absentees are not to be included). In order for a dog to be recognized as a Canadian Champion it must: (1) earn at least ten championship points under at least three different judges; (2) a two point win awarded either at the breed or group level; and (3) be individually registered in the records of the CKC or have a CKC Event Registration Number (ERN)

### CANADIAN KENNEL CLUB Non Member Participation Fee (April 2011)

ERN number: All dogs that are foreign born and owned and enter Canada for the sole purpose of entering CKC events will require an ERN. An ERN must be obtained within 30 days of obtaining points, awards or scores to avoid cancellation. If factors beyond your control prohibit this or present a problem, please send a written request for a 30 day extension to the CKC. An ERN may be obtained by contacting the CKC at: (416) 675 5511 or Fax (416) 675 6506

#### CKC Non-Member Participation Fee - (24-12-3)

- An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- "these fees apply only to dogs wholly owned by Canadian resident non-CKC members and are not applicable to CKC members"

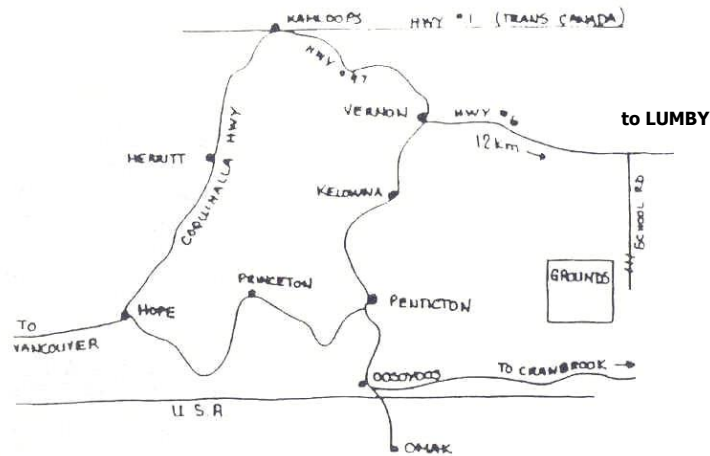

## Owner/Handler Unofficial Competition

### Exhibitor Eligibility

1. Exhibitors must enter the class for Owner/Handler competition to be eligible.
2. The handler must be an owner of record listed in the catalogue.
3. Professional handlers, household members and current assistants to professional handlers may not exhibit. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay or received payment for handling a dog.
4. Dogs must be handled by an owner-handler throughout the breed level competition for the regular show. This includes the class competition and subsequent competition in the breed ring. The same is true for all levels of group and show competition.
5. The Best Owner/Handler in Breed will be selected from the eligible dogs that competed in the Best of Breed competition for the regular show. This includes Winners Dog, Winners Bitch. This excludes all dogs defeated during class and winners competition for the regular show.

**Determining Best Owner/Handler in Breed** The selection of the Best Owner/Handler in Breed is held immediately following regular judging of that breed in the same ring. The ring steward will excuse all exhibitors not eligible. The judge will then award Best Owner /Handler in Breed.

Judging of the breed for the regular show may determine the dog that is awarded the Best Owner/Handler in Breed.

Guidelines:

- If the Best of Breed winner of the regular show is eligible for Best Owner/Handler in Breed it will also be awarded Best Owner/Handler in Breed. In this case the dog will be eligible to compete in group competition for the regular show and group competition for Best Owner/Handler in Group.
- If the regular show Best of Breed winner is not eligible for Best Owner/Handler in Breed and the regular show Best of Opposite Sex is eligible, the regular show Best of Opposite Sex will compete against the eligible exhibits of the other sex to determine Best Owner/Handler in Breed.
- If neither the Best of Breed nor the Best of Opposite Sex from the regular show is eligible for the Best Owner/Handler in Breed and both the Select Dog and Select Bitch are eligible, the judge is to choose Best Owner/Handler in Breed from the Selects and any eligible Winners Dog or Winners Bitch.
- If one of the Selects from the regular show is eligible for Best Owner/Handler in Breed, excuse all eligible champions and then choose Best Owner/Handler in Breed from the remaining eligible dogs of the opposite sex including the eligible Winners.
- If the regular show Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch are not eligible, the judge may choose any eligible dog remaining in the

ring including Winners Dog or Winners Bitch as the Best Owner/Handler in Breed.

If no dog remaining in the ring is eligible for the Best Owner/Handler in Breed competition, no award will be made and there will not be representation in group competition for the Best Owner/Handler in Group.

### Group and Best in Show Competition

- In the Group and Best in Show competition, the dog must be handled throughout the competition by an eligible owner.
- Group judging for the Best Owner/Handler in Group may take place in separate rings from regular group judging.
- Judging for the Best Owner/Handler in Show after regular Best in Show judging.

## Breeder/Owner/Handler Unofficial Competition

### Exhibitor Eligibility

1. Exhibitors must enter the class for Breeder/Owner/Handler competition to be eligible.
2. The handler must be a breeder of record listed in the catalogue.
3. Dogs must be handled by a listed breeder throughout the breed level competition for the regular show. This includes the class competition and subsequent competition in the breed ring. The same is true for all levels of group and show competition.
4. The Best Breeder/Owner/Handler in Breed will be selected from the eligible dogs that competed in the Best of Breed competition for the regular show. This includes Winners Dog, Winners Bitch. This excludes all dogs defeated during class and winners competition for the regular show.

**Determining Best Breeder/Owner/Handler in Breed** The selection of the Best Breeder/Owner/Handler is held immediately following regular judging of that breed in the same ring. The ring steward will excuse all exhibitors not eligible. The judge will then award Best Breeder/Owner/Handler in Breed.

Judging of the breed for the regular show may determine the dog that is awarded the Best Breeder/Owner/Handler in Breed.

Guidelines

- If one of the Selects from the regular show is eligible for Best Breeder/Owner/Handler in Breed, excuse all eligible champions and then choose Best Breeder/Owner/Handler in Breed from the remaining eligible dogs of the opposite sex including the eligible Winners.
  - If the regular show Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as the Breeder/Owner/Handler in Breed.
  - If no dog remaining in the ring is eligible for the Best Breeder/Owner/Handler in Breed competition, no award will be made and there will not be representation in group competition for the Best Breeder/Owner/Handler in Group.
- Group and Best in Show Competition**
- In the Group and Best in Show competition, the dog must be handled throughout the competition by an eligible breeder.
  - Group judging for the Best Breeder/Owner/Handler in Group may take place in separate rings from regular group judging.
  - Judging for the Best Breeder/Owner/Handler in Show is after regular Best in Show judging.
