
#### Official Map to the Saskatoon Retriever Glub Grounds

- Cheques payable to the Saskatoon Retriever Club (Canadian Funds). Must be dated no later than the closing date. Mail early. Email entries accepted with signed and legible entry form and must be accompanied by an etransfer payment only. No etransfers accepted for mailed entries. NO PHONE OR FAX ENTRIES WILL BE ACCEPTED.
- ♦ NO LATE ENTRIES will be accepted as in accordance to CKC rules.

- ◆ All entries must be accompanied by the full entry fee. A listing fee of \$8.50 + 5% GST = \$8.93 shall accompany an entry IF the dog does not have an individual CKC registration number or ERN number.
- Running order will be determined by a draw on Wednesday morning, June 14th. Multiple entries by the same owner/handler will be automatically separated unless otherwise requested.
- Pigeons, ducks or pheasants may be used on land and ducks will be used in the water.
- Standard CKC Rosettes to all dogs qualifying in each event.

### Policy Regarding Non-Members of the CKC

A non-member participation fee of \$62.40 +5% GST will be charged to a resident of Canada who is a non-member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs wholly owned by that individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.

#### **SCRATCHES**

Scratched entries will forfeit \$10.00 per entry when trial secretary is notified at least one hour in advance of the starting time on day of test. 'No shows' will forfeit full entry. Bitches in heat will be provided a full refund as they are not to be on test grounds at any WC Event.

\*\*It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind.
