**TCN Fee:** TCN # required for any dog without an individual CKC registration number, Performance Event Number (PEN) or CKC Event Registration (ERN), Miscellaneous Certificate Number (MCN), except for dogs entered in Exhibition Only. This TCN fee is \$10.50 per dog per each event entered during the field trial and is in addition to the entry fee(s).

**All entries for this Field Test are accepted on condition that the BSCC, its officials and members, land owners, are released from all liabilities for loss, damage or injury sustained by dog or person in conjunction with, or during the running of, this Field Trial. All minors shall be under the direct care and supervision of the parent or guardian.**

### TEST INFORMATION:

- **Courses & Birds** – Chukar and/or quail will be released. The tests will be over a single course with birds released along the course. There will not be a bird field. Three birds will be released for the first dog tested and two birds per dog thereafter. The BSCC reserves the right in case of a bird shortage, to use alternate bird species.
- **The Course** - Bird planters, marshals and judges shall be on foot. All participants & spectators must be on foot. **All dogs will be handled on foot.**
- **All persons on the course in FD must wear a blaze orange garment and hat. If you do not have one, one will be provided.**
- **Gallery:** A gallery of spectators may be permitted to follow the test dogs. This will be at the **sole discretion of the judges and handlers**. Spectators in FDJ and FD must remain together at all times and shall follow the directions of the judges, marshal, & gunners. All other spectators must remain in the camp area.
- Total entries will be limited to the **number of dogs** that can be run in approximately 8 hours of judging time.
- **Starting times** will be announced. (Earliest start will be 8 am.) Running times are an estimate only and may change due to absentees or dogs "picked up" early. It is the handler's responsibility to be at the start of the course when it is their turn to run.
- **FDJ & FD** dogs will have **20-30 minutes** to complete all aspects of the test. Dogs will be run individually in the FDJ & FD Tests.
- **Firearms** - Official gunners will be the only persons permitted to carry firearms on the test site. In FD, shotguns will be fired over dogs with bird work when possible. Shooting will be done by **official gunners** only. In FDJ blank pistols, .22 cal. minimum will be fired – **please provide your own starting pistol**.
- **Bitches in season** will be permitted to run. All bitches in season will be run at the end of the day on the respective course. Please notify the secretary or test chair if you have a bitch in season.
- **Collaring** a dog is allowed with the permission of the judge.
- **Tracking collars:** **Tracking collars will be permitted. Only tracking collars that meet the CKC guidelines will be allowed. A dog that is located using a tracking collar during its heat is no longer under judgement.**

- **Training or exercising** of dogs is prohibited on the test grounds during the test.
- **Smoking** is prohibited except in the designated headquarters area.
- **Accommodation:** Dry Camping at the Test Site has not been approved due to COVID 19 – please plan accordingly
  - **Other accommodations available in the area:** Fort Qu'Appelle, Indian Head, and Regina all have decent hotels. Echo Valley Provincial Park is very close, within 30 minutes of the grounds.
- **Food:** Will NOT be provided, please plan accordingly.
- **Prizes** - Rosettes will be awarded to all qualifying dogs. All ribbons are to be claimed at the Test – no ribbons will be mailed. **Due to Covid 19 we will attempt to get your scores and ribbons to you as quickly as possible after you run so you may leave.**
- **All participants and visitors will be required to sign a waiver. The waiver will be posted on the DOGSHOW.CA site as well as the club website. Please download prior to the event, if possible.**
- All participants must be familiar with CKC Rules and Regulations and also the rules, conditions and provisions of this Premium List. CKC Field Test Rules are available from the CKC. **NOTE: Make sure you review the rules for Field Dog Tests (available on the CKC website: [www.ckc.ca](http://www.ckc.ca))**
