The Table, Teeter, Dog-Walk and A-Frame are all rubberized. Tire is breakaway style. 24 inch weave poles will be used. Timing is Electronic.

Eligibility

To be eligible to compete in these trials a dog must be 18 months of age or older and have a CKC Registration number, ERN, PEN, CCN (Canine Companion Number) or MCN (Miscellaneous Certificate Number). Bitches in Season are not allowed to compete and will be refunded their entry and listing fees provided a Veterinarian's note stating that the bitch was in season within 10 days before the start of the trial and is submitted to the Trial Secretary on or before the day of the trial.

Non-Member Participation Fee

An annual non-member participation fee will apply to any exhibitor who is a Canadian resident and a non-member of the CKC earning awards/titles. In order to protect awards/titles earned the non-member will have to pay \$57.60 + tax for each dog being tracked by the CKC or become a CKC member within 30 days or notification. Failure to comply will result in loss of awards/titles.

Foreign Exhibitors

Please note that fees are due and payable in Canadian dollars. Discounted cheques will not be accepted. Cheques in US funds are accepted for the full amount of the entry and no exchange will be refunded. Please do not mark cheques "payable in Canadian funds" or "at par".
