In 1984 I applied for my first permit and at this time I am qualified to judge the Hound group (2), Working group (3), Herding group (7), the first half of the Toy group and on permit for the second half of Toys plus Best in Show. I belong to a local judging group that gets together on a regular basis to study various breeds and regularly attend dog shows to ringside judge when possible. I have judged in Canada, the US and Australia and am a member of the Canadian Dog Judges Association.

### LINDA KRAFT

Oriana (CKC Perm. Reg.) Golden Retrievers since 1974. Ainslie has participated in conformation, rally and obedience with some interest in working certificate/junior hunter training and tracking. Ainslie is a Life member of the Canadian Kennel Club, Golden Retriever Club of Canada and the GRCBC and is a member of the Golden Retriever Clubs of America and England. She has held numerous offices with both the national and local Golden clubs, including GRCBC newsletter editor and, for 11 years, coordinator of the GRCBC Rescue and Adult Placement Service. She is presently Chair of the Breed Standard/Judges' Education Committee for the GRCC and Chair of the Judges' Education Committee for the Golden Retriever Club of America.

For eight years in the 1990s, Ainslie hosted and produced "All About Pets", a monthly, live, one-hour program for Rogers Community TV, sponsored by the Western Federation of Individuals and Dog Organizations (FIDO). She is a former Board Member and volunteer with the B.C. Branch of Canadian Guide Dogs for the Blind and is a founder of the "Sporting Dog Spectacular" weekend in British Columbia.

Ainslie applied to judge conformation in 1991 and is now approved by the Canadian Kennel Club to judge the Sporting, Hound, Toy, Non-Sporting and Herding groups. She has had the privilege of judging throughout Canada and the United States as well as Australia, New Zealand and Indonesia. Ainslie has judged a number of sporting and herding specialties, including ASCA (Australian Shepherd Club of America) specialty shows, and sighthound show and go events, which combine coursing and conformation. She was very honoured to judge at the Golden Retriever Club of Canada National Specialty in 1998 and 2002. In 2004, she judged a record entry of over 430 Goldens at the Australian Golden Retriever National Specialty and assessed over 300 bitches at the Golden Retriever Club of American National Specialty in California. She judged the Nova Scotia Duck Tolling Retriever Club of Canada National Specialty in 2009.

Ainslie attended the AKC Judges' Institute in 1992 and regularly attends Judges' Education programs. She is an approved tutor and presenter for the Golden Retriever Club of America and has presented Golden Retriever seminars in Canada, the USA, Australia and Japan.

I have judged in South Africa, Zimbabwe, America, Canada, England, Ireland, Australia, New Zealand, Brazil, Thailand, Philippines and India.

I also have a passion for Junior Handling, both my children took part. I have visited numerous shows (including Crufts) in England, Ireland and World Shows in Europe, extending my knowledge of the different breeds, enjoying every minute, marveling as so many do, at the quantities and quality of dogs, I have made many friends on these trips.

I am Chairman of the Exco of KUSA and a Federal Councilor; I have been Chairman of Northern Natal Kennel Club for 6 years. I have 2 children Tyrone 30 and Kerrie 28 both with University Degrees. I am a qualified Bookkeeper.

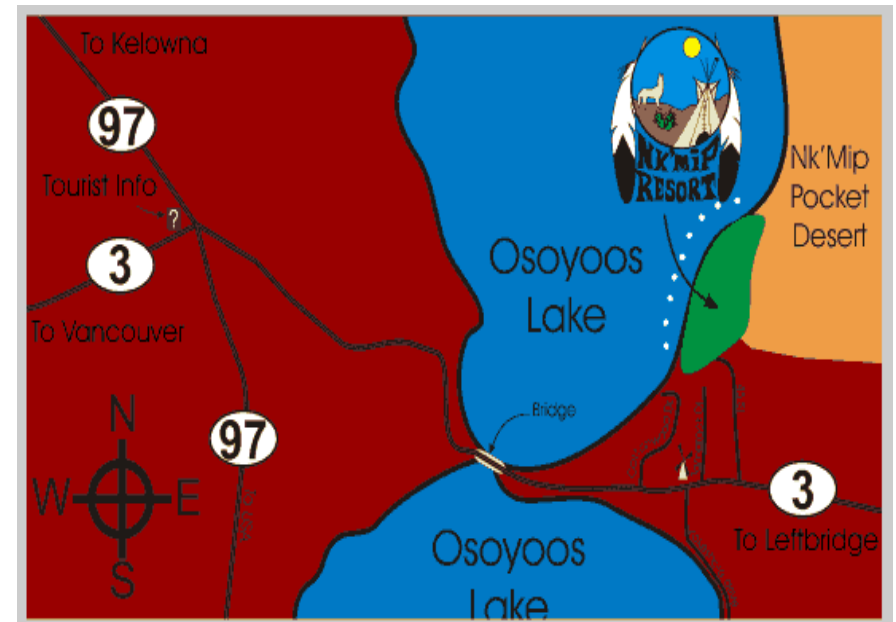

## **CONFORMATION CLASSES**

The following Regular CKC Classes (divided by sex) will be offered

**JUNIOR PUPPY CLASS** - This class shall be for any dog **6 months of age and under 9 months of age** on the day of the show

**SENIOR PUPPY CLASS** - This class shall be for any dog **9 months of age and under 12 months of age** on the day of the show

**12 to 18 MONTH CLASS** - This class shall be for any dog 12 months of age and under 18 months of age on the day of the show.

**CANADIAN BRED CLASS** - This class shall be for any dog born in Canada.

**(Champions of any country excluded)**

**BRED BY EXHIBITOR CLASS** - This class shall be for any dog owned and handled in the ring owner/breeder. The handler **MUST** be the owner/co-owner **AND** breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

**OPEN CLASS** - This class shall be for all dogs

**SPECIALS ONLY CLASS** - This class shall be for any dog which has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. **Note: A Listed dog MAY be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class MUST be received by the Show Secretary ONE HOUR PRIOR TO THE OPENING OF THE SHOW ON THE DAY CONCERNED. Listing Fees WILL NOT be refunded**

**EXHIBITION ONLY** - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class **MAY NOT COMPETE** in any Regular class but may enter and compete in Non-Regular classes and/or Parades ONLY

## **NON-REGULAR CLASSES**

**NOVICE "A"** - This class is open to all dogs, providing the dog has not earned the title of "CD" in ANY COUNTRY. **One dog ONLY may be entered in this class by any one exhibitor.** The exhibitor **MUST BE THE OWNER** or **A MEMBER OF HIS/HER IMMEDIATE FAMILY** and **MUST SHOW THE DOG IN ALL EXERCISES.** No licensed handler, trainer or any person who has previously exhibited a dog through its "UD" title in Canada or Elsewhere shall be allowed to compete in this class, but **MUST COMPETE IN THE NOVICE "B" CLASS**

**NOVICE "B"** - This class is open to all dogs which have not earned the title of "CD", and may be shown by the owner or any other person. The dog may not necessarily be CKC or ERN Reg'd to compete in this class

**OPEN "A"** - This class is open to all dogs which have earned the title of "CD" IN CANADA, but have not earned the title of "CDX" in any country. **One dog ONLY may be entered in this class by any one exhibitor.** The exhibitor **MUST BE THE OWNER** or **A MEMBER OF HIS/HER IMMEDIATE FAMILY** and **MUST SHOW THE DOG IN ALL EXERCISES.** No licensed handler, trainer or any person who has previously exhibited a dog through its "UD" title in Canada or Elsewhere shall be allowed to compete, but **MUST COMPETE IN THE OPEN "B" CLASS.** A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

**OPEN "B"** - This class is open to all dogs which have earned the title of "CD" in CANADA, and may be shown by the owner or any other person. This dog **MAY ALSO COMPETE IN THE UTILITY CLASS.** A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

**UTILITY CLASS 'A'** - This class is open to any dog of any recognized or listed breed which has earned the title of "CDX" but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a M.O.T.Ch title may not handle dogs in this class..This dog must be shown by the owner or a member of their immediate families. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter More than one dog in this class. The same person must handle the dog in all exercises. When a dog is wrongfully entered in this class, any score will be cancelled.

**UTILITY CLASS 'B'** - This class is open to any dog of any recognized or listed breed which has earned the title of "CDX" or U.D. Dogs in this class may be handled by the owner or any other person. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial. Prior to the start of judging, the judge will decide the order of exercises to be performed. This order will not be disclosed to exhibitors until it is posted at ringside, approx. 30 mins. Prior to the start of the class.

**PLEASE NOTE: The word 'trainer' means any person who conducts or has conducted a dog obedience training class or who regularly assists with the training of dogs in said class or who regularly trains dogs belonging to any person outside his/her immediate family**

**NOTE: Miscellaneous breeds entered in Obedience Trials that DO NOT have a Certification Number **MAY ONLY COMPETE AT THE NOVICE** level and **MUST** pay the Listing Fee applicable on a daily basis**

## **NON-REGULAR/UNOFFICIAL OBEDIENCE CLASSES**

ALL DOGS ENTERED IN A NON-REGULAR CLASS MUST ALSO BE ENTERED IN A REGULAR CLASS OR FOR EXHIBITION ONLY ON THE SAME DAY.

**VETERANS CLASS**- This class shall be for all dogs that have an obedience title and are 7 years old prior to the closing of entries. The exercises shall be performed and judged as in the "Novice Class".

### **DOGS ENTERED IN THE VETERANS CLASS MUST BE ENTERED IN A REGULAR CLASS**

## **TRANSITION OBEDIENCE CLASSES**

**PRE-NOVICE** – This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have not earned the title of P.C.D. (Pre-Companion Dog) in Canada. Dogs being entered in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class and must have an additional handler for each dog when they are judged together on the Group exercise. A dog may be entered in the Pre-Novice that has not earned the title of C.D. in Canada or a comparable title in any other country. The Pre-Novice class is an elective class and earning a title is not a requirement to advance to the Novice Classes.

**NOVICE "C"** – This class is open to any dog of either sex that has gained the title Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada prior to the closing date of the trial in which it is to be entered. Exhibitors may enter more than one dog in this class but must have a separate handler for each dog in the Long Sit and the Long Down Exercises when they are judged in the same group. The Novice 'C' exercises will be performed and judged as described in the official Novice Class except that exhibitors may compete in the Novice 'C' Class indefinitely. Scores earned by dogs entered in the Novice 'C' Class are not eligible for High In Trial. The P.C.D. and C.D.I. and Novice 'C' are elective classes which are offered for those people who feel the dog requires ring experience and acclimation to the trial situation or would like to earn additional titles. Dogs may be entered in the Novice – Intermediate (C.D.I.) and/or Novice 'C' class in addition to any of the Official Classes or Unofficial Classes.

**NOVICE INTERMEDIATE CLASS** – This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have earned the title of (C.D.) Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada. A dog eligible for entry in the Open A or B Class at any obedience trial held under these rules is also eligible for entry in the Novice 'C' and Novice Intermediate Class at the same trial. The Novice Intermediate class (C.D.I.) is an elective class and earning a title is not a requirement to advance to a Companion Dog Excellent title. Scores earned by dogs competing in this class are not eligible for High In Trial. Dogs are eligible to compete in this class indefinitely. Dogs in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class.

## EXTRACTS FROM THE CONFORMATION SHOW RULES & REGULATIONS

### JUDGES – SECTION 4.1.3

A judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see this rule is effectively carried out.

### SHOW OFFICIALS – SECTION 5.1.5

A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.

### ENTRY FORMS – SECTION 8.2.3

Entry forms received by the CKC, which are incomplete and/or contain incorrect information may result in awards being cancelled.

### ENTRY FORMS – SECTION 8.2.5

An error in an age-specified class, the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.

### ENTRIES - SECTION 8.3.1

Every dog entered in a conformation show must be one of the following:

- (a) registered with the CKC
- (b) have an Event Registration Number
- (c) eligible for registration with the CKC, or
- (d) if it belongs to a listed breed, it must have a Miscellaneous Certification Number (MCN)

### REFUSAL OF ENTRIES – SECTION 8.6.2

A Club may refuse any entry form from an exhibitor known to have tendered a dishonoured cheque or declined credit card unless entries are accompanied by cash, money order or certified cheque.

### DISQUALIFICATIONS – SECTION 14.1.4

Once a dog has been disqualified for any reason at a conformation show, it may not be entered or shown at another show until the dog has been reinstated by the CKC. All awards earned by the dog shown in violation of this section will be cancelled by the CKC and the owner of the dog is subject to disciplinary action.

## **RULES GOVERNING THESE SHOWS AND TRIALS**

2. ANY DOG EXCUSED BY THE SHOW SUPERINTENDENT OR VETERINARIAN FOR ANY REASON SHALL NOT, COMPETE IN ANY CLASS FOR ANY AWARDS FOR THE BALANCE OF THE SHOW.
3. THE SHOW COMMITTEE WILL USE DUE CARE AND DILIGENCE FOR THE WELFARE OF DOGS AND EXHIBITORS, BUT WILL NOT BE RESPONSIBLE FOR, OR ASSUME ANY LIABILITY IN THE EVENT OF ACCIDENT OR MISFORTUNE TO EITHER DOGS, EXHIBITORS, SPECTATORS OR VENDORS.
4. DOGS MUST BE ON THE GROUNDS 1 HOUR PRIOR TO THE JUDGING OF THEIR BREED.
5. THE OWNER OF A DOG ENTERED IN THESE SHOWS IS ENTIRELY RESPONSIBLE FOR ANY ERROR IN ENTERING HIS/HER DOG REGARDLESS OF HOW OR BY WHOM ENTRY WAS MADE
6. EXHIBITORS AND HANDLERS WILL BE RESPONSIBLE FOR THEIR DOGS AND EQUIPMENT LEFT AT THE SHOW GROUNDS.
7. DOGS TO BE EXERCISED IN DESIGNATED AREAS ONLY, NOT IN VICINITY OF RINGS
8. ALL RECREATIONAL UNITS WILL HAVE BUCKETS UNDERNEATH FOR THEIR SINK DRAINS. ANYONE FOUND DISCHARGING WATER ON THE GROUNDS WILL BE REMOVED BY ORDER OF THE HEALTH DEPARTMENT, AND MAY BE SUBJECT TO A FINE.
9. IF, BECAUSE OF CIVIL DISTURBANCE OR OTHER ACTS BEYOND THE CONTROL OF THE CLUB, IT IS IMPOSSIBLE TO OPEN OR COMPLETE THE SHOW, THERE IS NO REFUND OF ENTRY.
10. DOGS MUST BE ON LEASH AT ALL TIMES ON THE SHOW GROUNDS OR WITHIN THE SHOW BUILDING WITH THE EXCEPTION OF THE OBEDIENCE RINGS.

**ALL EXHIBITORS, HANDLERS AND PATRONS ARE EXPECTED TO KNOW AND ABIDE BY THE CKC DOG SHOW RULES**

### **CHAMPIONS AND CHAMPIONSHIP POINTS**

SECTION #1. A dog awarded WINNERS at a Championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION #2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows;

To determine the number of points earned by a dog awarded Winners, total all dogs in competition which were defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best Opposite Sex and then consult the schedule set forth above. The point system provides for additional points if a class dog awarded Best of Breed also places in the group as listed below;

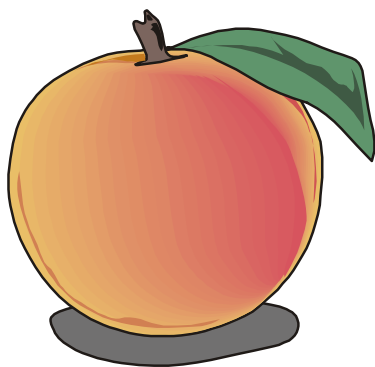
