Trials will be limited to 3.5 hours of judging per trial, get your entries in early! Day of entries will be accepted at the door if not filled in advance. Pre entries close June 1<sup>st</sup>, 2022, 9:00 pm.

This event will be held under the rules of the Canadian Kennel Club (CKC). As per CKC rules, dogs entered in an obedience sanction match must be six (6) months of age or older and must be eligible for CKC registration. Any qualifying scores earned in a sanctioned match do not count toward official titles. A dog may be entered in and participate in any class for which it has a CKC title, but it is not eligible for ribbons/cards/awards. Only those dogs who earn qualifying scores in a class for which they do not yet have a CKC title will be awarded a ribbon/card.
