DAY-OF-TRIAL ENTRIES

Day-of-trial entries will be accepted both February 13 and 14, 2021. Entries must be made at least 30 minutes before the start of the trial. Day-of-trial entries will be cash only.

BENCHING

Limited Benching Only – Reserved spots for multiple dog competitors are crates only and must be reserved/approved by trial chairperson only. Sign up by emailing ribbon2sweet@gmail.com five days after entries close. No ex-pens allowed.

ADDITIONAL INFORMATION

- ◆ The scoop-up requirements will be strictly enforced.
- ◆ There will be **NO "In Transit"** area provided. No dog will be allowed in the building unless entered in the Trials.
- ◆ There will be no "overnight" kenneling.
- ◆ Only approved CKC collars will be allowed in the precincts of the trials.
- ◆ SHOWING correct information on the entry form is the responsibility of the entrant. However, Exhibitors incorrectly entered in the "A" class are permitted to move the dog to the corresponding "B" class up to one hour before the start of the trial. The SKOC takes no responsibility for omissions or errors made on the entry forms. The Show Committee reserves the right to refuse any entry subject to the CKC rules.
- ◆ BITCHES IN SEASON: Obedience entry fees WILL be gladly refunded to exhibitors whose females are in season during the trials (and must be withdrawn) IF: a dated veterinarian's certificate is produced prior to the trial.
- ◆ THE PRECINCTS of these trials shall be the Manhattan Ballroom building & grounds.
- ◆ KNOWLEDGE of the Canadian Kennel Club Rules is the responsibility of the entrant. Rule books may be obtained from the CANADIAN KENNEL CLUB, 200 Ronson Drive, Suite 400, ETOBICOKE ON M9W 5Z9, Telephone: 416-675-5511

- ◆ The SKOC will use due care and diligence for the welfare of the dogs and exhibitors but will not be responsible for, or assume any liability in the event of an accident or other misfortune, either to dogs, exhibitors or spectators.
- ◆ All dogs must be under complete control at all times.

- ◆ 20.7 It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an obedience or rally trial held under these regulations, is not subject to indignities of any kind. The Trial Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

PLEASE NOTE:

When entering the same dog in multiple classes a separate entry form MUST be filled out for EACH class.

There will no food or drinks available for purchase.

COVID-19 CKC OBEDIENCE TRIAL ALLOWABLE CHANGES

- ◆ Handler will place their leash, dumbbells etc. in a designated spot and pick up after their run. The ring steward will NOT bring your leash to you. Your dog must leave the ring on-leash and under control.
- ◆ Utility handlers please bring tongs as you may be required to handle your own articles. Stewards will wear new disposable gloves if handling scent articles and bag.
- ◆ Qualifying Rosettes, ribbons and score sheets will be left on a table for handlers to pick up if they wish at end of their class. No ribbon/rosette presentations in the ring.
- ◆ Special prizes will be verified by Trial Chair or Event Secretary and will be placed out at time of award in specified location.
- ◆ There will be no printed catalogues. Electronic Copies may be provided by email.
- ◆ Pylons will be used for Figure 8 posts at all levels
- ◆ Group Stays – dogs will be placed a minimum of 8 feet apart for all levels. A dog that fails to qualify in the Individual Exercises will not be eligible to compete in the Group Exercise.
- ◆ NOTE – Jump Heights for dogs will be according to their correct height at the withers or for accepted veteran heights. There will be no reduced heights incorporated into these trials.

COVID-19 INFORMATION – SUBJECT TO CHANGE

- ◆ All Saskatchewan Health Authority (SHA) regulations will be followed.
- ◆ If you are exhibiting ANY symptoms of COVID-19, please do not attend the trials. Any handler unable to attend these trials due to exhibiting COVID-19 symptoms after entries close will receive a credit to any future CKC event hosted by the Saskatoon Kennel & Obedience Club. Credits will expire after one year.
- ◆ MASKS will be mandatory at time of Premium List for all competitors on the precinct of the trial. New restrictions may be made at time of event according to SHA regulations.
- ◆ ONLY handlers entered in the specific class being judged will be allowed into the building and we ask that you space yourselves at least 10 feet apart. There will be temporary benching spots for dogs/crates during class and vacated after class to make space for exhibitors in following classes. Large classes may be broken up into groups and you will be invited in as others leave to accommodate the Group Exercises.
- ◆ NO Spectators
- ◆ **ALL competitors will be required to sign a waiver form and must turn waiver in at venue upon arrival, before competing. Waiver is available on DogShow.ca**
