## **ENTRIES AND FEES**

**Entry fee per dog, per test: WC: \$50.00 WCI/WCX: \$55.00.** Entries close **Monday, August 20** at 9:00 p.m. or when entry limits have been reached.

Listing fee per test of \$10.00 + HST (\$11.30) must be submitted for any dog without an individual CKC registration number or ERN.

**Please fill out separate entry forms for each dog and each day.** Confirmation of receipt of entry will NOT be sent. Bitches in season will NOT be permitted to run.

**Move-ups for Sunday's test accepted up to 8:00pm Saturday August 25/18.**

No entry will be accepted unless all particulars called for on the entry form are completed in full. Incomplete entries will be returned. No entry will be accepted unless accompanied by the Entry Fee. Telephone entries cannot be accepted, except in the event of a postal disruption. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made. The committee reserves the right to refuse any entry subject to CKC rules. Any NSF cheques will be subject to a **\$30.00** service charge. Entry fee plus service charge for NSF cheques must be paid in cash prior to test.

**PLEASE NOTE: Effective January 1, 2011 - Non-Member Participation Fee**

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

Head East on Hwy 417 to first exit past Casselman (Hwy 138)  
Drive south on 138, over railway tracks, until you see sign for Warina  
Turn left on Warina Rd  
Continue to "T" intersection; turn right on Bender Road  
Continue to next intersection and turn left on Robinson's Corners - 17694 Robinson's Corners Road  
Turn right (south) on road across from barn and follow signs
