## ENTRIES

**The Senior and Junior will be run together; therefore, dogs cannot be entered in both stakes on the same day.**

1. Entries can be made through [dogshow.ca](http://dogshow.ca), email with e-transfer, or regular mail via cheque. There will be a tailgate on Saturday for a cost of \$10.00. See below for details



A service charge of 5% will be assessed. This includes entries sent online, by fax or post using a credit card or interac for payment.

4. Cheques **must** be made payable to The Manitoba Gun Dog Association and must be dated no later than the closing date (June 09, 2024).
5. Draw will take place on Sunday, June 09, 2024 at the home of the Hunt Test Secretary.
6. All dogs will run in the order drawn.
7. Separate OFFICIAL CKC ENTRY FORMS are required FOR EACH DOG in EACH STAKE.
8. All entries must be accompanied by the Entry fees noted and, if dog is entered with a Temporary Competition Number (TCN) they must include the TCN fee of \$10.50, including GST.

### IMPORTANT PARTICIPANT INFORMATION:

Handlers may be needed to throw birds or other duties, when not running their dog.

**NON CKC MEMBER PARTICIPATION FEE** “these fees apply only to dogs wholly owned by Canadian non CKC members and are not applicable to CKC members.”

**SCRATCHES** will forfeit \$15.00. To be considered, “NO SHOW” refunds must be requested in writing to the Hunt Test Secretary no later than fourteen days after the trial, explaining the reason for the scratch.

**DUCKS and/or PHEASANTS** may be used in all stakes

**CLOTHING** In keeping with the aim of simulated hunting conditions and situations, handlers, judges, workers, and other test participants shall be attired in dark or customary hunting attire, which adequately reflects a water fowling or upland hunting environment and provincially required blaze orange for the upland test, where applicable.

**STANDARD CKC ROSETTES** will be awarded for all qualifying dogs.

**CAMPING and TRAILER PARKING** is available. However, there are NO electrical hook ups and NO water.

## IMPORTANT NOTICE TO EXHIBITORS AND JUDGES

### **3.8 Hunt Test: Indignities to a Judge**

3.8.1 A judge officiating at a hunt test held under these rules shall not be subjected to any indignities of any kind during the progress of the hunt test. It shall be the duty and obligation of the club holding the hunt test to see that this rule is effectively carried out.

### **3.9 Hunt Test: Judge's Conduct**

3.9.1 A judge must conduct himself in a manner that is fair and not prejudicial to the sport.

### **20 Hunt Test: Discipline**

20.7 It shall be the duty and obligation of the event-giving club to see that a judge, club official, volunteer, or any participant at a hunt test held under these regulations, is not subject to any indignities. The Hunt Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

Furthermore, the Manitoba Gun Dog Inc. will assume no liability in the event of an accident or other misfortune to event participants, bystanders, club members, workers or other individuals using the property for any purpose.
