All entries must be accompanied by the entry fee in full. All Owners of unregistered dogs, CKC recognized breeds entering events are required to obtain a Temporary Competition Number (TCN). TCN can be obtained through CKC Online Portal, or by submitting a completed Paper application by mail to CKC or by contacting Shows and Trials toll free at 1-855-364-7252. Scratches will be refunded for a bitch in season totally. All other scratches will be refunded at the field trial committee's discretion, other than a fee of \$5.00.

RULE 21.7 of the Field Trial Rules States: "It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Retriever Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.
