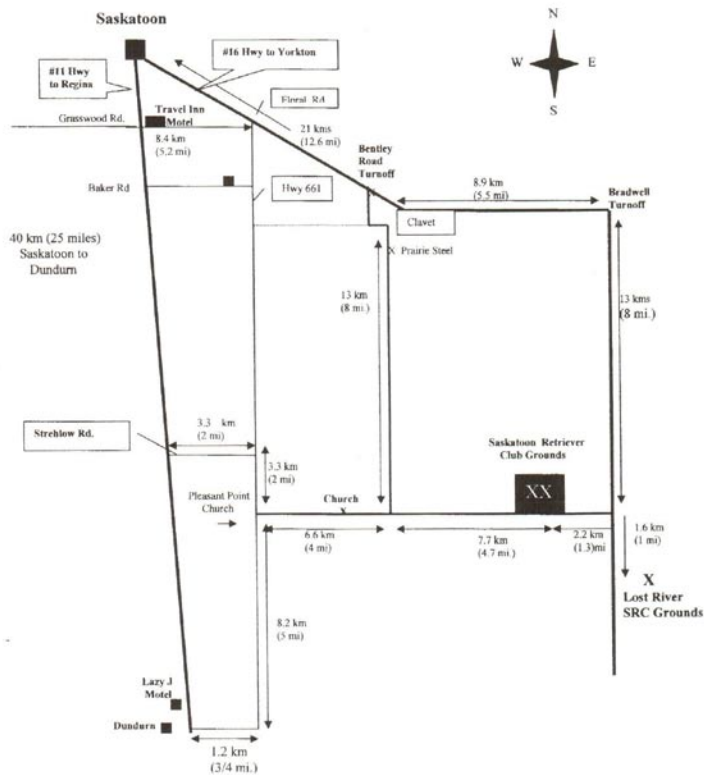

- ◆ Cheques payable to the Saskatoon Retriever Club (Canadian Funds). Must be dated no later than the closing date. Mail early. NO PHONE OR FAX ENTRIES WILL BE ACCEPTED.
- ◆ Mail cheques and completed entries to: **Shelly Campbell, Event Secretary, RR#6 Site 601 Box 58, Saskatoon, SK, S7K 3J9**, Ph. (306) 374-1214. A separate entry form for EACH DOG in EACH STAKE is required.
- ◆ All entries must be accompanied by the full entry fee. A listing fee of \$8.40 + 5% gst = \$8.82 shall accompany an entry **IF** the dog does not have an individual CKC registration number or ERN number.
- ◆ Running order will be determined by a draw. Multiple entries by the same owner/handler will be automatically separated unless otherwise requested.
- ◆ Pigeons, ducks or pheasants may be used on land and ducks will be used in the water.
- ◆ Standard CKC Rosettes to all dogs qualifying in each event.

Policy Regarding Non-Members of the CKC

A non-member participation fee of \$59.40 +5% gst will be charged to a resident of Canada who is a non-member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs wholly owned by that individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.

SCRATCHES

Scratches will forfeit \$10.00 per entry if trial secretary is notified at least one hour in advance of the starting time on day of test. Bitches in heat will be provided a full refund as they are not to be on test grounds at any WC Event.

****It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.**
