Exhibitor Notice 2024

Access with dogs only to either Hall 1 and/or Hall 2
is by way of emergency exit doors at either end of the Halls.

Access of dogs with equipment is only via Hall 2 emergency exit doors.

If the over-head door(s) in Hall 2 are open during move-in and/or move-out, dogs and equipment are welcome.

Vendors are permitted to drive into Hall 1 provided they arrive within the first two hours of opening On Wednesday 10:00 am.

Dogs and/or exhibitors with equipment are not permitted to access or exit via the North public entrances (ie. the ones with glass double doors).

Any mess created by your dog or damage caused by your equipment must be cleaned or remedied immediately.

Dogs are be only be exercised across from the South side of Hall 2 in the designated exercise area. At no time are they to urinate or defecate on/in/near the venue structures, garbage cans, barriers, etc.

Failure to comply at any time on venue grounds is subject to immediate disciplinary action.
