**ENTRIES:** Please complete **one entry form per dog, per stake, per day** in which you wish to enter your dog(s). All entries must contain complete information as required by the CKC rules. **Scratches** will be refunded in full for a bitch in season and injured dogs. Other scratches maybe refunded at the field trial committee's discretion, less a \$10.00 fee. Entry forms on National Retriever Club of Canada website <u>www.nrcc-canada.com</u> (under Official Business tab/Download Forms) and Canadian Kennel Club website <u>www.ckc.ca</u>. (under Events tab/Event Forms)

**Temporary Competition Number (TCN):** Starting March 2, 2020 all owners of unregistered CKC recognized breeds entering events are required to obtain a *Temporary Competition Number* (TCN). Dogs not registered in Canada must obtain a TCN <u>before submitting an entry for a field trial.</u> TCN's can be obtained from the CKC online, by paper application, or by contacting the Shows & Trials division toll free at 1-855-364-7252. A TCN fee of \$10.50 must be included with your entry for the trial. The same TCN must be used for all event entries until the dog is permanently registered. CKC Registration or ERN must be applied for within 30 days of the trial or all awards will be cancelled.

## NOTICE TO COMPETITORS AND SPECTATORS

**Release and Indemnification of Landowners and Alberta Retriever Clubs Association:** By entering this event, each participant agrees to assume all risks and hazards incidental to participation in the event and agrees to release, save harmless and indemnify the owner(s) of the property upon which the event is held, together with their agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person, dog, or property of the participant howsoever caused, arising out of or in connection with the participant's use or entry upon the property. It is understood that this agreement is binding upon the participant and all of his heirs, executors and assigns.

**RULE 21.7 of the Field Trial Rules States:** "It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Retriever Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue."
