In consideration of the acceptance of this entry, of the holding of the event, and of the opportunity to have the dog participate and/or to be judged, I (we) agree to hold the organizing committee, the hosting club, the CARO Canadian Association of Rally Obedience, including their members, officers, directors, agents and employees, sponsors of the event, and owners of the premises upon which the event is held and their employees, harmless from any claim for loss or injury that may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim. I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, appearance, theft, damage, or injury be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. There will be designated crating areas for dogs inside the building. A canteen/lunch will be available. All dogs must be kept in an x-pen, crate or on leash when not in the ring. Any dog engaging in aggressive behavior at any time will be required to leave the premises. In such cases, no refund of fees will be paid.

Sta B, Fredericton, NB, E3A 5G9), must be made in writing, and must be postmarked no later than June 1, 2014.
