The Trial entries will close when the limits are reached, or on the closing date, whichever comes first. Same day entries will be accepted for an additional fee if there is space. Please contact secretary to verify space after closing date.

General Information	Obstacle familiarization will be NOT available. Obstacles shall meet the specifications in the CKC Agility Rules and Regulations effective January 1, 2017.
Event Information	To be eligible to compete in the agility trials, a dog must be 18 months of age. ALL dogs my be registered or be eligible for registration with the CKC, have an ERN or CKC Miscellaneous Certificate or Performance Event Number (PEN) or CKC Mixed Breed Number to compete in agility. Spayed bitches, debarked dogs, and neutered males are eligible to participate. Trial Secretary and Superintendent is in full charge of the Trials. The show precincts consist of the agility rings and 10 feet around the rings Food and toys are not permitted in the course area or within 10’ of the ring gates, and handlers are not permitted to use whistles, clickers, flexis or other instruments or devices within 30’ of the ring. Bitches in season are also NOT permitted within 100’ of the Agility ring. Dogs must be ON LEASH at all times when outside the ring, and everywhere on the trial grounds. PLEASE STOOP TO SCOOP!
Agility Obstacles	Agility ring surface is outdoors on grass. Agility handlers in all classes will be able to walk their course, without their dog prior to the start of the class.
Eligibility	Handlers must be ready at the start line when called or risk forfeiting their run. If a dog is not at ringside after it has been called 3 times, it will be marked absent. Please advise us ASAP if you have a conflict and we will accommodate your needs.
Bitches in Season	Bitches in season <u>may not compete</u> and may not be within 100’ of the agility ring When a bitch comes into season after the entry has closed a Veterinarian’s certificate, certifying the bitch was in season within the 10-day period preceding the trial must reach the secretary on or before the start of the trial. A full refund of entry fees and listing fees will be given.
Ribbons / Trophies	Through the generosity of its members and friends, the Ontario Nova Scotia Duck Tolling Retriever Club will offer the following at the Agility Trial: 1st to 4th in each Class – Q Rosette New Title Rosettes will be given Thank you to the Red Barn Event Centre for offering a prize for the High Aggregate Scoring Toller in each of Novice, Intermediate, Excellent and Master classes on Saturday. Scores from the Standard and JWW classes will be combined, to get the aggregate score. Handy Toller Award The purpose of this award is to demonstrate the working ability of Tollers and to reward those that give an outstanding performance in a variety of official events on the weekend of the Ontario NSDTR Club’s Specialty. To qualify for this award, a Toller must be entered in a minimum of 3 Events. Events are to include Field, Agility, and either Obedience or Rally Obedience. 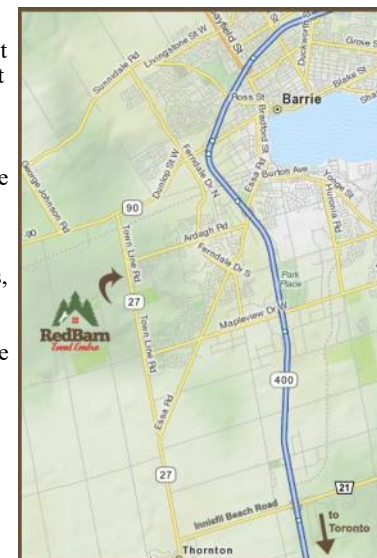

Directions to The Red Barn Event Centre:

From the 400: Take the Essa Road exit. Turn west on Essa (sign says Essa Road South). Turn right at Ardagh Road. Follow Ardagh to County Road 27. (aka Town Line Road) Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.

From CR 27 South: Follow CR 27 northbound through Thorton. Continue north. After 5 minutes, look for signs on your right that show you have to turn LEFT to stay on CR 27. When you see that sign, turn left, continue on CR 27. When you come down the big hill look for our white flags on the west (left) side of the road. If you get to lights at Ardagh, you’ve gone too far.
