**General**

1. The building will be available Thursday after 4:00 pm for set up. On Friday, Saturday and Sunday will be open at 7:00 am
2. No dogs are to be left in the building overnight.
3. There is to be NO food brought in or consumed within the show premises. All that is allowed in is bottled water.
4. It is suggested that all crates have a waterproof covering under them.
5. Please exercise your dogs frequently to avoid accidents in the building.
6. There is RV parking available but no services.
7. There is a canteen which will be open each day.

**Trial Information**

1. Running order will be Novice, Intermediate, Excellent. Class heights will run tall to small for the whole weekend.
2. Move ups are available to the next class between days or one hour before the start of the next trial on the same day by completing the required Move-up Form. Please note Move-ups are permitted for dogs with a CKC Reg, PEN, ERN, MCM or CCN numbers only
3. Participants in the trials will be required to volunteer. A volunteer schedule will be available on the Maritime Agility Trial FB page, and will be posted at the trials.
4. Trial Precincts: Indoors - the area includes the agility ring and the area of the building designated by the Trial Committee for indoor crating and areas designated for the use of the Trial Secretary, Judge and Committee.
5. No equipment familiarization will be offered for Novice dogs.
6. Warm-up jumps will be provided in proximity to the ring area
