**NO POST DATED CHEQUES** accepted. ALL NSF cheques are subject to a charge of \$20.00. N.S.F. Cheques are considered Non-Payment of entry fees and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the tests.

Attention Foreign exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank you.

#### ATTENTION ALL CANADIANS WHO ARE NOT CKC MEMBERS

Effective January 1, 2011, the CKC has instituted an annual Non-Member Participation Fee for awards and titles for a CANADIAN non-member of the CKC. These fees apply only to dogs wholly owned by a non-CKC member and are not applicable to CKC members. Non CKC member participants must either purchase a CKC membership or pay the non-member participation fee within 30 days of notification or the CKC will cancel any awards and titles. More information, and application forms can be downloaded from the CKC website: http://www.ckc.ca.

Each dog may only be entered in ONE of the WC, WCI or WCX test. A dog must have a WC title before entering the WCI test, and have achieved a WCI title before running the WCX test.

Bitches in season **MAY NOT** compete in the tests.

Entry and listing fees paid for any dog withdrawn because of a bitch being in season, injury, illness or death shall be refunded in full. An appropriate veterinary certificate must be given to the Test Secretary <u>BEFORE</u> the start of the tests to qualify for a refund.

Catalogue order will be determined by draw on <u>August 13<sup>th</sup>, 2019</u>. This will be the running order, unless prior arrangements are made with the Field Marshall.

Ducks will be used for both the land and water marks.

All Gunners, Judges and Competitors should wear dark or camouflage clothing. Handlers shall not wear white or light coloured at any time, but handlers may wear handling jackets for the blinds in WCX.

All qualifying dogs will be awarded a CKC rosette.

Electric collars (either dummy or alive), prong or pinch type collars shall not be worn by any dog on the grounds, at any time during the event.

ENTRIES & END OF TEST
6.8 Disqualification & Reinstatement

#### **DELETE CURRENT**

- 6.8.2 At his discretion, a judge shall have the authority to excuse or disqualify a dog which menaces, threatens, attempts to bite or bites the judge, another person, or another dog in the field. When a dog is twice excused on this account, it shall have the status of a disqualified dog.
- 6.8.3 At his discretion, a judge shall have the authority to permanently disqualify a dog which bites the judge or another person in the field. Dogs disqualified under this provision will not be eligible for reinstatement. The decision to permanently disqualify a dog must be clearly indicated on the Judge's Disqualification Form.

#### **REPLACE WITH NEW**

- 6.8.2 The judge shall have the authority to disqualify or excuse a dog which menaces, threatens, or attempts to bite the judge, another person, or any dog in the field. If a dog is twice excused for any combination of these actions, it shall have the status of a disqualified dog. The judge shall also have the authority to disqualify or excuse a dog which attempts to bite, or bites in response to an attack from another dog.
- 6.8.3 The judge shall disqualify or permanently disqualify a dog which bites the judge, another person or any dog in the field. Dogs permanently disqualified under this provision will not be eligible for reinstatement. The decision to permanently disqualify a dog must be clearly indicated on the judge's disqualification form

There will a designated area (land and water) available for airing your dog(s) on the test grounds. Contact the Field Marshall upon arrival at the test site to confirm location of both prior to airing your dog(s).

#### **DIRECTION TO TEST SITE**

<u>From Fredericton</u>: Follow the Hwy 101 until Hwy 655. Turn left onto Waasis Rd, go apx. 3.5 km's and turn right onto Wilsey. Go through covered bridge turning left onto Rusagonis Road. Go apx 3.5 km's and turn right onto Sunpoke, another 3.5 km's and turn right onto Dewitt. Tests are at #91, apx. 1 km on left.

**From Saint John/Oromocto/Moncton**: Follow the transcanada until exit 297. At the end of the ramp, turn past the Irving Big Stop and go to the end of the Road. Turn right, go 1.3 km's and turn left onto Rusagonis Rd. Go apx 3.5 km's and turn left onto Sunpoke. Go another 3.5 km's and turn right onto Dewitt. Tests are at #91, apx. 1 km on the left.

\*\*\*\*Please note that if you are using a GPS system, you will need to enter "Witt Road" instead of DeWitt in order to find the location.\*\*\*\*

It is understood that this agreement is binding upon the participant, or his/her heirs, his/her executors and assigns.

#### Section 14.7 CKC Working Certificate Test Rules and Regulations

The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred."
