**Judging Assignments** 

Lunch breaks will be at the judge's discretion. Shadow Judges will be participating which may have an impact on how quickly the trials proceed.

10 min/20 participants will be allowed for competitors to walk the course prior to trial except for Advanced and Excellent C and Team where the walkthrough is 3 minutes for 10-12 participants.

Please Note: Food or toys MUST be in the RIGHT-HAND POCKET of the handler, <u>OUT OF SIGHT</u> NO TREAT/BAIT BAGS. NO ACTIVE TOYS (clickers, laser, squeak toys, etc)

To keep the event running smoothly, all competitors will be expected to keep track of the running order and to be in the 'on deck' area prior to your run.

# **FACILITIES**

This is an OUTDOOR facility 25 kms. south of Brandon. Bring your own seating, shade tent, etc. Washrooms, water and snacks will be provided. Lunch will not be provided – please bring your lunch if you are staying all day and do not want to return to Brandon. Fast food/full service restaurants, hotel/motel, camping, hospital, vet, etc. is available in Brandon.

All dogs must be crated, in an ex-pen, or on leash when not in the ring. Any dog engaging in aggressive behaviour at any time will be required to leave the trial grounds.

ALL CHILDREN MUST BE SUPERVISED BY A PARENT NOT COMPETING IN THE TRIALS.

ANYONE OBSERVED NOT PICKING UP AFTER THEIR DOG WILL BE EXCUSED AND WILL FORFEIT ENTRY FEES.

ANYONE OBSERVED DISCIPLINING THEIR DOG IN A MANNER THAT OFFENDS A JUDGE'S SENSIBILITIES WILL BE EXCUSED AND WILL FORFEIT ENTRY FEES.

# **WEATHER**

This is an outdoor trial, and it's in MANITOBA (weather unpredictable). In case of severe weather, we will attempt to wait it out and delay the trial however, the trial will proceed rain or shine. No refunds will be given due to inclement weather. This is also the Brandon Hills and tick central. Check your dog for ticks every evening.



#### **DIRECTIONS TO TRIAL SITE**

The trial will be held at Two Brown Dogs Canine Consultants outdoor training site south of Brandon, MB.

Turn SOUTH off #1 Trans-Canada on #10 Hwy. (18<sup>th</sup> Street). Continue south through Brandon 18 kms. past the Zeller's Mall to Tower Rd. Turn left (EAST) and travel 4 kms (2 ½) miles. We are the last drive on the left side of the road and it will be well marked.



#### **GENERAL AGREEMENT**

I (we) agree that the Canadian Association of Rally Obedience (CARO), Two Brown Dogs Canine Consultants, and Prairie Dog Day Care (the host organizations and venue) have the right to refuse this entry for any cause, which the organizing committee alone shall deem to be sufficient. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death resulting at any time therefore sustained by any person or persons, including myself (ourselves), or on account of damage to property arising out of or in consequence of my (our) participation in this event, howsoever such injuries, death, or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

I (we) further acknowledge that I (we) have read, understand, and will abide by the Official Rules and Regulations of the Canadian Association of Rally Obedience and the provisions for entry as set forth in the Rally Test Schedule of which this entry form is part. I (we) acknowledge and represent that the information supplied by me (us) herein is correct to the best of my (our) knowledge; if any portion of this information is found to be invalid or insufficient to establish the validity of my (our) entry, such finding shall render my (our) entry invalid in its entirety, for which there shall be no refund of fees paid.

Further, I (we) represent that I am (we are) the owner(s) of the dog listed heron, or that I am (we are) a family member of the dog's owner as stated and allowed in the CARO rules, and that I (we) shall hold the hosting club, CARO, Two Brown Dogs, and PDDC, including their officers, directors, employees, and agents and their spouses, harmless from any liability or claim made by the dog's owner(s).
