DRIVING DIRECTIONS

633260 Artemesia-Glenelg Town Line Priceville, Ontario

From Toronto: Take Hwy 400 to Airport Road or Hwy 10 north to Hwy 9. Go west to Orangeville, where you will turn northwest onto Hwy 10. Take Hwy 10 to Flesherton where you will turn left (west) onto Hwy 4, travel 7 kms, then turn left (south) onto Artemesia Glenelg Townline Road, drive straight through intersection and first driveway on right

From Guelph: Take Hwy 6 into Arthur. Turn right (northeast) onto CR 14. Take this road, driving through Hopeville, then watch for an "S" bend in the road. After you go through the "S" bend in the road, you will make the first left (west) onto our road – Southline "A". Go along about 2 kilometers and turn left on Artemesia-Glenelg Town Line and first driveway on right

From Milton/Rockwood: Take Hwy 25 north to Hwy 124, turn left (west) travel 4 kms turn right (north) on 26. This road will take you into Bellwood Lake. Then turn left (west) onto 19, then turn right (north) onto 16. Take this road to the end, at Hwy 89 where you will make a short left (west). Less than ½ a km you will turn right (north) on Concession 11. This road turns into CR 14 (so DO NOT TURN). Take this road, driving through Hopeville, then watch for an "S" bend in the road. After you go through the "S" bend in the road, you will make the first left (west) onto our road – Southline "A". Go along about 2 kilometers and turn left on Artemesia-Glenelg Town Line and first driveway on right

From London, Ontario: Take Hwy 401 east to Hwy 6 north into Guelph. Follow Hwy 6 into Arthur. Turn right (northeast) onto CR 14. Take this road, driving through Hopeville, then watch for an "S" bend in the road. After you go through the "S" bend in the road, you will make the first left (west) onto our road – Southline "A". Go along about 2 kms and turn left on Artemesia-Glenelg Town Line and first driveway on right

From Kitchener/ Waterloo: Take Hwy 86 north to 12, where you will turn right (north). This road will take you into Arthur, where you will turn left (northwest) onto Hwy 6, Then less than ½ km turn right (northeast) onto CR 14. Take this road, driving through Hopeville, then watch for an "S" bend in the road. After you go through the "S" bend in the road, you will make the first left (west) onto our road – Southline "A". Go along about 2 kilometers and turn left on Artemesia-Glenelg Town Line and first driveway on right

From Hamilton: Take Hwy 6 north, pass over Hwy 401 through Guelph and into Arthur. Turn right (northeast) onto CR 14. Take this road, driving through Hopeville, then watch for an "S" bend in the road. After you go through the "S" bend in the road, you will make the first left (west) onto our road – Southline "A". Go along about 2 kms and turn left on Artemesia-Glenelg Town Line and first driveway on right

From Niagara: Take the QEW into Hamilton, where you will turn north onto Hwy 6. Then take the directions from Hamilton.

The Draft Dog Test Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

GENERAL INFORMATION AND TEST RULES:

It is the responsibility of the exhibitor to be familiar with the rules Pertaining to the event in which they are competing. Copies of the CKC Draft Test Regulations are available from the Canadian Kennel Club

As per the Draft Dog Test Rules and Regulations, the group option as stated in **Section 11.2, is not offered at this test.**

As per Section 4.1. q Bitches in season are not allowed to compete. To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching the Test Secretary after the official closing date as published in the premium list or after the maximum number of entries has been received.

No Entry will be accepted unless all particulars called for on the entry form are shown thereon. Incomplete entries will be returned. No Entry will be accepted unless accompanied by the entry fee.

Telephone, and fax entries cannot be accepted.

Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made. Cancellations of any entry after the closing day are prohibited. The Club reserves the right to refuse any entry, subject to CKC Rules. Identification and judging schedules will be e-mailed as soon as possible after **entries close.**

ELIGIBILITY: Open to all purebred CKC recognized breed dogs Eighteen months of age or older on the day of the event. Every Dog Entered must be one of the following: Registered with the CKC; have an Event Registration Number (ERN); eligible for registration with the CKC have a Performance Event Number (PEN), have a Canine Companion Number (CNN) or Miscellaneous Certification Number (MCN). Entries in the Draft Dog Excellent Test must have a CKC Draft Dog (DD) Title. Entries in the Brace Draft Dog Excellent Test must have a CKC Brace Draft Dog (BDD) Title. The Judges must excuse a dog at any time during a Test for lack of physical capacity.

ENTRIES: Entries must be complete, signed & submitted on the official CKC entry form. The order of competing shall be the order that entries are received except that dogs handled by the same person will be separated when possible. No delays will be permitted for handlers entering more than one dog and entrants doing so must have an alternate handler available for the group down exercise if a conflict arises. Re-qualifications will be accepted pending space available. Re-qualifications shall be judged as the last team in the section for which they are entered. After the closing date we notify all entries by email.

BITCHES IN SEASON: Bitches in season are NOT allowed to compete at this test. If you have entered and your bitch comes into season, your entry fee will be refunded when a note from your vet is provided to confirmation she is in season.

EQUIPMENT: Each entrant to supply his or her own equipment and apparatus. The test committee will supply the freight load. DDX Entrants must provide their own backpacks and backpack weight.

TEST REGULATIONS: All dogs must complete and pass all exercises in the Novice Draft Dog, Draft Dog and Draft Dog Excellent test, under all 3 judges to be awarded the title.

ENTRIES CLOSE: 8:00 p.m. Friday September 13, 2019 or when the limit as outlined on front of this premium list is reached, even if official closing date for entries has not arrived. If combination of DDX/BDDX entries has not been received by the closing date these openings may be filled with additional NDD or DD/BDD entries. Entry fees will not be refunded after the closing date. With the exception of bitches coming into heat. If the limit is reached prior to closing date, a list of alternates will be kept filling any vacancies created due to early (prior to closing) cancellations. Entry fees will be refunded within 10 days following the Test to all withdrawals replaced by an alternate and to all alternates and re-qualifications that did not participate in the test. Email confirmation of receipt of entry will be provided to entrants who provide a valid, legible email address on their entry form.

FOREIGN BORN/OWNED DOGS: A dog not individually registered with the CKC may be entered at a test held under these regulations as a "Listed" dog, provided it has an event registration number (ERN) or obtains this from the CKC within 30 days of the first test entered otherwise scores will be canceled. An ERN (Event Registration Number) can be obtained by contacting the Canadian Kennel Club, Show & Trails Division, 200 Ronson Drive., Suite 400, Etobicoke, Ontario M9W 5Z9. NON-MEMBER: Non CKC Member Participation Fee - Canadian Residents Only: the CKC has a Non-Member Participation fee for all Canadian residents who participate in a CKC event but are not CKC members. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. This applies to dogs wholly owned by non-members resident in Canada and does not apply to U.S. exhibitors nor to CKC members or dogs co-owned with a CKC member.
