HEAD SOUTH ON HWY 17 TOWARDS VICTORIA FOR APPROX 11 KMS THEN TURN RIGHT AT MT NEWTON CROSS RD (TRAFFIC LIGHTS). TURN LEFT AT WALLACE DRIVE (4 WAY STOP). TURN RIGHT ON STELLYS X RD & SAANICH FAIRGROUNDS WILL BE ON YOUR RIGHT.

DIRECTIONS FROM NANAIMO

HEAD SOUTH ON HWY 1 TOWARDS VICTORIA & TURN LEFT ONTO MCKENZIE TO HWY 17 HEADING NORTH TOWARDS THE SWARTZ BAY FERRY TERMINAL. AT APPROX 15KMS, TURN LEFT AT MT NEWTON CROSS RD (TRAFFIC LIGHTS). TURN LEFT AT WALLACE DRIVE (4 WAY STOP). TURN RIGHT ON STELLYS X RD & SAANICH FAIRGROUNDS WILL BE ON YOUR RIGHT.

THE RCMP BARN WILL BE OPEN FOR EARLY CRATE SET UP FRIDAY NIGHT FROM 6-8PM

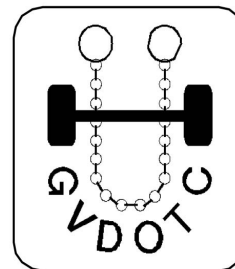
PARKING IS NO LONGER PERMITTED IN THE STABLE ISLEWAYS
