#### **Attention Exhibitors**

Please note that fees are due and payable in Canadian dollars. Due to fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send your cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques, "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge you to purchase bank drafts or money orders payable in Canadian funds.

#### Non-Member Participation Fee

The Non-Member *Participation Fee* applies to dogs wholly owned by a resident of Canada who is not a member of the CKC, it is not applicable to CKC members or dogs co-owned with a CKC member. In order for the title to be awarded, the non-member will have a choice of either becoming a CKC member or paying the Non-Member Participation Fee. Failure to comply within thirty (30) days of notification will result in the title being withheld and the dog cannot be moved up. For a membership application, please go to www.ckc.ca under CKC Services and Form on-line. The Non-Member Participation Fee is fee paid in the calendar year (January-December) in which the dog achieved its title.

#### Attention All Foreign Exhibitors

To obtain an ERN do the following: Send a photocopy of the dog's registration certificate reflecting current ownership - with a written request for an ERN.

Include full payment. Accounts may be paid with personal or business cheque, money order, Visa or Mastercard. For Non-Members please note that if paying by cheque, the cheque must be certified. Non-residents of Canada please note that discounted cheques or money orders will not be accepted due to fluctuating currency rates.

Provide your full return address. Faxed requests will be accepted. Please include your VISA/ MasterCard number, expiry date, cardholder's name and signature. An ERN must be obtained within 30 day of obtaining points, awards or scores to avoid cancellation. If factors beyond your control prohibit this or present a problem, send a written request for a 30 day extension.



- 1. Only dogs that are already registered in the Canadian Kennel Club Stud Book, or are eligible for such registration can be entered.
- 2. To comply with instructions issued by the Canadian Kennel Club entries reaching the Show Secretary after the closing date as published in the Premium List cannot be accepted.
- 3. Entries cannot be accepted unless all particulars called for on the entry form are filled in. ie. DOB, sex, place of birth etc..
- 4. Only entries accompanied by the entry fee will be accepted.
- 5. No telephone entries are allowed.
- 6. Exhibitors must abide by errors made in entering their dog (s) regardless of how or by whom the entries were made. Change or cancellation of any entry after the closing day is prohibited.
- The Kars Dog Club has the right to refuse any entry-subject to C.K.C. Dog Show Rules.
- 8. The SHOW SUPERINTENDENT will be in full charge of the show, which will be governed by C.K.C. Rules.
- Identification cards and judging schedules will be mailed as soon as possible after the close of entries.
- 10. The person accompanying the dog must show the identification card before the dog is allowed in the show. Unless a dog is officially entered, it will not be allowed on the show precincts.
- 11. Dogs need only arrive 15 minutes prior to scheduled judging.
- 12. It is the responsibility of the exhibitor to have the dog in the ring when the dog's class is schedules for judging.
- 13. Severn Show Services and the Show Committee will use due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident, or other misfortune, to either dog, exhibitor or patron.

Points may not be carried from the regular competition judging to the Altered class judging.

These classes shall be for any spayed or neutered dogs over 6 months of age. Dogs will be judged after the judging of the Best Puppy in Breed in the Regular classes, and after Veteran Classes.
