CLOSING DATE: WEDNESDAY, OCTOBER 7, 2020, at 6:00pm. The Club cannot accept entries delivered after this date and time. Any entries received after the closing date will be discarded. All duplicate entries received for the same dog in one event will be discarded. All entries must be on an official CKC entry form. Please list all relevant tracking titles only. Any incomplete or improper entry forms will be discarded. Owners are responsible for any errors made on the entry form regardless of who completes the entry form. **SEND BY MAIL ONLY.** No courier, emailed, faxed or hand delivered entries will be accepted. The Test Secretary will notify the entrant by email on the day the entry is received.

ENTRY DRAW: A random entry draw will take place on **THURSDAY, OCTOBER 8, 2020, at 6:00pm.**

Location: Tim Hortons, 62 Carleton Ave Unit 110, Red Deer, AB T4P 0T9. Entry draw will follow the draw procedure as outlined per CKC rule 2.2.4.

CLUB WORKER DRAW: At the entry draw one TD track will be reserved per CKC rule 6.6.2. "Club Worker" is defined by Central Alberta Tracking Society policy.

GENERAL INFORMATION:

**** SATURDAY/SUNDAY:** If the TDX tracks on Saturday and the TD tracks on Sunday do not fill, we may offer a different track level (up to maximum allowed exchange per CKC rule 6.2.2), depending on venue and tracklayer availability. Exhibitors may send in an additional entry and cheque for a chance at a TD track on the Saturday or for a chance at a TDX track on the Sunday. If the TDX tracks fill on Saturday & the TD tracks fill on Sunday, a refund will be sent within 10 days of the test date for all TD entries received for Saturday and for all TDX entries received for Sunday.

PAYMENT: Please make all cheques payable to Central Alberta Tracking Society. Fees must accompany each entry. No post-dated cheques will be accepted. A Temporary Competition fee as established by The Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form. **NOTE:** There will be a \$50.00 service charge on all **NSF** cheques received. Tendering an **NSF** cheque shall be considered **NON-PAYMENT OF ENTRY FEES** and is an offense punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club.

US EXHIBITORS: Covid-19 border restrictions may preclude U.S. entrants from participating in these tests. If these restrictions are lifted prior to the closing date, U.S. entrants may pay fees by money order payable in Canadian funds OR by personal cheque in U.S. funds for the full amount of the fees. Personal discounted cheques will not be accepted and please do not mark cheques "Payable in Canadian Funds" or "At Par" as these will not be accepted. Bank drafts or money orders payable in Canadian Funds are the best choice. Please make bank draft, cheque, or money order payable to Central Alberta Tracking Society.

REFUNDS: Withdrawn entries after closing date will only be refunded where there is an "Alternate" available who chooses to fill that assigned entrant's vacancy on test day. Alternates will be contacted in catalogue order and advised of the opening. They may choose to accept the spot and become responsible for the entry fee or decline and bear no financial obligation. Anyone on the "Alternate List" may request a refund at any time prior to test day. Entries will be refunded within 10 days of the test date to those on the alternate list that did not participate in the test.

BITCHES IN SEASON: Bitches in season will be permitted to compete but will be assigned the last track. Please advise the Test Secretary as soon as possible if your bitch is in season for the test.

RIBBONS: A ribbon stating "Passed TD" or "Passed TDX" will be awarded to dogs earning these titles.

RENDEZVOUS LOCATION & TRACK DRAW: Rendezvous location & time for track draws will be sent by the Test Secretary by email to each exhibitor after the entry draw is done. Due to Covid-19 restrictions the Test Secretary will be handling the draw items. In catalogue order, exhibitors will advise the Test Secretary which item they would like, and the item will display the track number that the dog & handler will run.

NEW TITLES: For those competing at the TDX level, please indicate on the entry form if a TDX pass will give the dog its Tracking Champion Title or its Master Tracking Champion Title.

AWARDS & NO-HOST LUNCHEON: Due to Covid-19 restrictions, there will be no luncheon after the tracking test each day. A ribbon will be given at the field to all passing teams. If the handler would like the judge to sign their end glove, please let the Test Secretary know so this can be done at the field, between tracks if time permits, otherwise after the last track is completed. Additionally, if a team completes their Tracking Championship with a TDX pass, a medallion & certificate will be awarded and if a team completes their Master Tracking Championship with their second TDX pass under the requirements specified for this title (per CKC rule 8.1.4), a special award along with a certificate will be awarded for this achievement.

PHOTOS: All photos for passing teams will be done at a physical distance of 6 feet/2 meters if possible and if a physical distance cannot be maintained, a mask must be worn by all persons in the photo. Alternatively, we can take a photo of the passing team separately without the Judge & tracklayer.

SPECTATORS: Due to Covid-19 restrictions, spectators will not be permitted during each test date.

COVID-19 Safety: Exhibitors are asked to remain in their vehicle upon arrival for the track draw. The Test Secretary will instruct you on the track draw procedure once all exhibitors have arrived. If you need to potty your dog, please do so at a distance away from the immediate draw area. Exhibitors must wear a mask if a physical distance of 6 feet/2 meters cannot be maintained at any time. Please bring your own mask, hand sanitizer and garbage bag for when you are out at the field to dispose of any garbage, disposable masks/gloves and dog poop. You are responsible for taking your own garbage and dog's waste with you from the field.

There will be no beverages or food provided at each test. Exhibitors are encouraged to bring their own.

Once you have completed your test please go to your vehicle and remain in it. If you need to potty your dog, please do so away from the other exhibitors making sure only one dog is out at a time. If you have passed, the Test Secretary or a CATS volunteer will bring your ribbon and a copy of your map to you. If you would like a photo done please let us know when we bring your ribbon & map. These will be done once the last track is completed and in track order. If you don't want a photo done you may leave the site to go home.

At the test site, we will have a "home base parking area" where exhibitors are required to stay in their vehicle at this spot until you are called to run your track. In some cases, we may need to move the team competing to the location of their track if it is not close to the home base parking area. If you need to potty your dog please maintain a physical distance as outlined in the first paragraph above and wear your mask when you cannot maintain a physical distance of 6 feet/2 meters. Please make sure you clean up after your dog and take all poop bags with you.

Only the Judge, tracklayer, Superintendent, the dog and handler will be allowed on track. All other exhibitors must remain in their vehicle at the home base parking area unless you are done your test and want to leave.

Articles will be scented by the tracklayer prior to laying the track on test day. All exhibitors are encouraged to bring a bag for putting articles in and wear protective gloves if you want to pick up the article after your dog has indicated it. Alternatively, exhibitors may leave the article on the ground for the tracklayer to pick up.

If you are feeling unwell prior to or on the day of the test, please inform the Test Secretary immediately (at the contact info provided in the email confirming your position in the test), stay home, take the self-assessment, and follow all recommendations for self-isolating on the Alberta Health Services website at the following link: <https://www.albertahealthservices.ca/topics/page16997.aspx>

A refund will only be given as stated under “Refunds” above in this situation after the closing date.

RULE 14.7: It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

PLEASE NOTE TO ALL NON-MEMBERS OF THE CANADIAN KENNEL CLUB: Effective January 1st, 2011 an annual non-member participation fee for all awards and titles will be charged to a Canadian nonmember of CKC. The fee will match the ERN fee \$64.00 + 5% GST. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. This fee applies only to dogs wholly owned by non CKC members and not dogs co-owned by a CKC member. Entries shall not be accepted from any person who is not in good standing with the Canadian Kennel Club on the day of entries closing.

EXHIBITORS PLEASE NOTE: It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. New Tracking Test Rules & Regulations came into effect and were published January 1, 2020.

EXHIBITORS MUST BE PRESENT WHEN IT IS THEIR TURN TO RUN THE TRACK. Exhibitors that are not present when their name is called will be disqualified.

Exhibitors may not train on the tracking fields (this includes urban areas designated for an urban test) within 14 days of the test (CKC rule 6.1.10).

Do not leave dogs unattended, please pick up after your dog, all dogs must be kept on leash and under control at all times if not securely confined.

Central Alberta Tracking Society will exercise all reasonable care for the safety of the dogs competing, but will not be held responsible for the loss, damage, or injury to any dog, handler or owner, children not under the control of their parent or guardian and their property.

DISCLAIMER OF LIABILITY: Central Alberta Tracking Society members, volunteers and the land owners will use due care and diligence for the welfare of dogs and exhibitors, BUT will not be responsible for, nor assume any liability in the event of an accident or other misfortune to either dogs, exhibitors or patrons. By entering this Test each participant agrees to assume all risks and hazards incidental to participation in the Test and agrees to release and to save harmless and indemnify the owner(s) and/or leasee(s) of any property upon which the Test may be held together with their officers, agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person or property of the participant howsoever caused, arising out of or in connection with the participant's use or entry upon the property. My signature on the entry form indicates that I understand and agree to the above and to abide by rules of the current Official CKC Rules and Regulations as well as rules set forth by Central Alberta Tracking Society concerning this event.
