**2022 National Retriever Championship Qualification Requirements:** Entry in the National Retriever Championship Stake shall be limited to the winners and finalists of the 2021 National Retriever Championship stake and those dogs that have placed 1st, 2nd, 3rd or 4th in an Open, Special, Limited, Amateur or Owner Handler Amateur All Age Stake approved by the Canadian Kennel Club in which championship points were awarded and hosted by a Class A National Retriever Club of Canada Member club, this current year (2022) and the previous calendar year (2021).

Listing fees for dogs not individually registered with the CKC are \$11.30 (includes HST) per dog.

**Entries close Monday August 29 at 6:00 pm ET.** Entries received after that time will not be accepted. Entries received without payment will not be entered into the draw. The draw will be held at the home of the Field Trial Secretary for the running order.

**Scratch Fee Policy:** Bitches in season may not compete and must be withdrawn. All entry fees paid for bitches in season will be returned to the owner or agent, provided a notice in writing is given to the Field Trial Secretary before the start of the stake.



Entry fees paid for any dog withdrawn because of an injury, illness or death, shall be refunded in full. Prior to such refund the host club may require an appropriate veterinary certificate to be given to the Field Trial Secretary before the start of the stake.

**Pre-Trial Training:** Maps showing training grounds will be available at Field Trial Headquarters. Training birds may be purchased from the host club at Field Trial Headquarters. Training Birds must be pre-ordered.

**NRCC Directors Meeting:** Saturday September 10<sup>th</sup> at 11:00 am to 1:00 pm at Field Trial Headquarters - Baypoint Kennels.

**NRCC Annual Meeting of Members:** Saturday September 10<sup>th</sup> at 1:00 to 3:00 pm at Field Trials Headquarters - Baypoint Kennels.

**Banquet:** Saturday September 10<sup>th</sup> at The Mill Eatery and Inn at 20 John Pound Rd. Tillsonburg, ON. Cocktails at 5:30 pm. Banquet followed by Calcutta at 7:00 pm.

**Vetting:** Sunday September 11<sup>th</sup> 3:00 - 5:00 pm at Field Trial Headquarters – Baypoint Kennels. Only females will be required to be vetted. The vetting must take place within the 24 hour period preceding the stake and must be done by the official veterinarian. Spayed females will be exempt from vetting if a veterinary certificate of spaying accompanies the entry form.

**Starting Time:** 8:00 am Eastern Time on Monday September 12<sup>th</sup>. Test dogs will run at 7:30 am.

**Starting Location:** To be announced and location will be marked.

**Game Birds:** Ducks and/or pheasants will be used in all tests.








## Participant Information

### New National Format:

**National Field Trial Champion NFTCH** - The National Field Trial Champion title, NFTCH, is awarded to the winner of the National Retriever Championship stake.

**National Amateur Field Trial Champion NAFTCH** - The National Amateur Field Trial Champion title, NAFTCH, is awarded to the top Amateur handled dog when the winner is handled by a Professional and the top Amateur handled dog completes the 10<sup>th</sup> series of the National Retriever Championship stake.

**National Finalists** are the dogs who complete the 10<sup>th</sup> series without an eliminating fault.

### Revised Rules:

**CKC Rule 14.4.1** The winner of the National Retriever Championship Stake shall become a Field Trial Champion of Record and shall be entitled to be designated the National Field Trial Champion of (year).

**CKC Rule 14.5.1** The best amateur handled dog that completes the tenth series of the National Retriever Championship Stake shall become an Amateur Field Trial Champion of Record and shall be entitled to be designated the National Amateur Field Trial Champion of (year).

**Photos:** Participants agree that their image, and that of their dog may be used by any official sponsor of the National Retriever Club of Canada to promote the sponsor's business endeavours in perpetuity and without further compensation.



**CKC Rule 21.7:** It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer, and or any participant at an event held under these rules is not subject to indignities of any kind. The Retriever Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**Release and Indemnification of Landowners and The National Retriever Club of Canada and Long Point Retriever Training Club:** By entering this event, each participant agrees to assume all risks and hazards incidental to participation in the event and agrees to release, save harmless and indemnify the owner(s) of the property upon which the event is held, together with their agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person, dog, or property of the participant howsoever caused, arising out of or in connection with the participant's use or entry upon the property. It is understood that this agreement is binding upon the participant and all of his heirs, executors and assigns.
