GENERAL INFORMATION

Limited Entry

We will accept entries only via regular mail or priority post (do not send requiring a signature upon delivery). No entries will be accepted before **9:00 am October 16, 2013**

ONLY ONE ENTRY PER ENVELOPE.

IN THE EVENT OF A MAIL STRIKE, HAND DELIVERED ENTRIES WILL BE ACCEPTED.

Positions will be assigned on a first come first served basis. Once the limit has been reached, all remaining entries shall be assigned a position on the "Alternate List" in the order they are received. The Club will upon receipt of entries notify by mail the person making the entry that such entry has been received and accepted for the primary test or their position as an alternate.

Payments

PLEASE MAKE ALL CHEQUES PAYABLE TO "WESTERN GREAT DANE CLUB OF B.C."

The appropriate fee must accompany all entries.

A \$8.82(incl. GST) listing fee must accompany an Entry fee for all foreign born/owned dogs not having an individually registered CKC number or either an Event Registration or Performance Number

U.S.A. entrants should make payment through Money Order made out in Canadian Funds.

Personal cheques will be accepted, however they must be payable in U.S. funds and for the full amount of the entry. Personally discounted cheques will not be honored. Please do not mark cheques "payable in Canadian funds"; as such items are not readily cleared through the banks.

Meeting Place and Draw

TD & TDX TRACKS the meeting place will be the parking lot of Campbell River Store at the corner of 8 Avenue & 176 Street Surrey, BC where the draw for tracks will take place on **NOVEMBER 3, 2013 at 7:15 AM.**

UTDX TRACKS the meeting place will be at the "Tim Hortons" 17878 56th Ave. (#10 Highway) Surrey, BC where the draw for tracks will take place on **NOVEMBER 4, 2013 at 7:45 AM.**

Any primary entrant(s) who is/are absent at the assigned time will forfeit their position to the first available Alternate(s) present.

Disclaimer of any Liability

In attending this test, competitors, spectators and guests acknowledge they do so at their own risk and that of any dog. They also agree they will not hold liable the C.K.C., The Western Great Dane Club of B.C., it's club or test officials, the Judge or the landowner(s) for any loss, damage or injury, however arising, to themselves, their dog(s), or any chattels.

Bitches in season will be allowed to compete, but will run last. Please advise Test Secretary **immediately** upon arrival at the meeting place.

Awards and No-Host luncheon A memento will be awarded to all successful competitors by the judge. A No-Host luncheon will be held after the test.

Manure Please note the possibility exists that manure may be on fields

Refunds When the respective test has been filled entries are automatically closed even although the published "Closing Date" may not have been reached. An entry received after entries have closed will be assigned a position on the Alternate List. If a dog is withdrawn after the entries are closed, refunds will only be permitted where there is an "Alternate" available and actually fills the vacancy.

Statement It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Non-member participation fee – Effective January 1, 2011

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) in order to protect the awards/title earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of the notification will cause all the awards and titles to be cancelled.
- c) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.
