## NOTICE TO EXHIBITORS

Exhibitors, through submission of entry, acknowledge that they are familiar with AAC rules and regulations, including but not limited to the following:

This event is open to all dogs at least 18 months of age, purebred or mixed breed, except aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance.

Obstacles shall be chosen from those described in the current edition of the rules and regulations of the MC. No leads, collars, except flat collars, food, toys or other aids or devices shall be permitted on the course at any time. No toys or food on course during familiarization. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may be asked to leave the show grounds and no refund of fees paid will be made. Exhibitors must keep crating and exercise areas clean. Please pick up after yourself and your dogs.

There will be no refund after the closing date for dogs that are withdrawn except for sick/injured dogs if we are provided with a vet's certificate.

## **AAC Policy Pilot Program July 1st, 2022 – December 31, 2023**

Under the AAC pilot project, bitches in season (BIS) may participate but we must be notified ahead of time. Handlers must limit movement of the BIS and only the designated relief area. A (BIS) must wear panties at all times, while on the property except while in the relief area and during their run. The BIS will run at the end of each class and the handler must provide a mat for the start line. Competitors who chose not to compete because there is a BIS will be offered credit for the next trial.

**Agility Association of Canada General Agreement**

I/We, the undersigned, agree that the Host Club has the right refuse my entry for causes, which the organizing committee shall deem to be sufficient.

In consideration of the acceptance of this entry and the holding of the event and the opportunity to have the dog participate or, be judged.

I/We hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage caused by bodily injuries, including death at any time resulting thereof, sustained by any person or persons, including myself/ourselves or on account of damage to property, arising out of or in consequence of my/our participation in this event, however such injuries, death or damage to property may be caused and whether or not the same may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.
