## **GENERAL INFORMATION:**

**Eligibility to Compete** - To be eligible to compete in these trials, the dog must be 6 months of age and registered or be eligible for registration with the CKC, have an ERN, PEN or a CKC Miscellaneous Certificate number. A dog may be spayed, neutered or debarked.

**Bitches in season** - Bitches in season are not permitted to compete under C.K.C. Rules. We will refund all entry and listing fees if a bitch comes into season after closing date, upon presentation of a veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trials. This certificate must be delivered to or reach the Trial Secretary before the trial commences.

**Rally Obedience Classes offered** - All regular classes will be offered (Rally Novice A & B; Rally Intermediate; Rally Advanced A & B and Rally Excellent A & B and Master).

**Rally Team Class offered** – One unofficial class, **Novice Team Class** will be offered on Sunday, September 30, 2018.

**Rally Obedience Prize List** - Flat ribbons will be given for all qualifying scores. Rosettes for qualifying First placement for Novice A and Novice B, Intermediate, Advanced A and Advanced B and Excellent A and Excellent B, and Master level. Flat ribbons for all 2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> placements. Title rosettes will be available.

**Important Notice to Rally Obedience Exhibitors** - There is no limitation on the number of trials at which a dog may be entered as a 'listed dog', except that a dog which has obtained three qualifying scores at obedience trials held under C.K.C. rules, may not continue to compete at licensed obedience trials held under the Club's rules until the dog is registered individually with the C.K.C. Foreign born and owned dogs, please refer to Event Registration Number (ERN) information listed elsewhere.

**Rally Obedience Trial Rules and Regulations** - The Exhibitor is responsible for knowing and complying with the Rally Obedience Rules and Regulations of the Canadian Kennel Club. Section 20.7 of the Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at an Obedience or Rally Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indication that this has occurred.

If the entry has no CKC individual registration number, an E.R.N. or a P.E.N. is required and must appear on the entry form. A listing fee of \$11.30 per entry is also required.

**NSF Cheques** - Tendering of a dishonoured cheque for entry fees shall be considered non-payment of entry fees, and is an offence punishable by disciplinary action and cancellation of awards (6.3.3 of the Obedience Trial Rules & Regulations)

All fees include H.S.T. and must be paid in Canadian Funds. USA Exhibitors we require money orders in Canadian funds, negotiable in Canada.

**CKC Non-Member Participation Fee / Non-member participation fee** - An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be canceled. The Premium List must carry a note stating that "these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

**UNOFFICIAL CLASSES (and only applicable for Novice Class for this event), taken from the Obedience Trial and Rally Obedience Rules & Regulations**

- 19.3.1 Eligibility for Team classes shall be the same as that listed for the obedience Team class, except that the class is open to any four dogs that have earned a title of RN or higher.
- 19.3.2 Clubs may offer any of these classes: **Rally Novice**, Rally Intermediate, Rally Advanced, Rally Excellent and/or Rally Master.
- 19.3.3 Each team member will run the course individually, with the team time running continuously. The judge will give the first member of the team the “Forward” command from the Start sign. Each subsequent dog and handler will start when the previous dog and handler pass the Finish sign, without any additional command of “Forward” by the judge. Timing for each team will begin when the judge commands “Forward” to the first handler in the team and will stop when the fourth handler and dog pass the finish line.
- NA - 19.3.4 If jumps are required, the height will be based on the height of the smallest dog on each competing team.
- NA - 19.3.5 There will be no Sit Stay (Sign #298) or Stand Stay (Sign #398) included if the class is offered at the Excellent or Master level.
- 19.3.6 Scores will be based on a possible score of 400 points for each team, with ties being broken by time. Each dog and handler will be scored as in official classes. A qualifying score is 280 points or more except in the Master class, where 320 or more points is required.
- 19.3.7 Suggested judging rate is four teams per hour.
