General Information:

Venue: To be held in an unheated barn. Packed sand footing. Bathroom is heated. Dress in layers. There is NO concession on site. However, there will be coffee and hot water available. Stores & restaurants are a 5 minute drive. Parking for large recreation vehicles unavailable (sorry).

CARO Dog ID Cards: Dogs of at least six months of age must be registered with CARO in order to be eligible to compete for CARO Rally awards and titles. The dog identification card or proof of individual dog registration from CARO, which could be "pending" at the time of registration for the trial, must be presented to the trial secretary in order for the dog to compete at the trial. Handlers may choose to submit the Individual Dog Application form (see end of this Premium) filled out and accompanied by a cheque to CARO for the amount required to the Trial Secretary.

Awards: Qualifying ribbons will be awarded to each team that achieves a score of 170 or better.

Move-Ups: Permitted at the end of the first day (or between classes only if time permits).

For Exhibition Only (FEO): You may enter any class FEO if desired. Please indicate FEO on Entry Form in the tick box.

For Class Details: Please refer to the CARO website (e.g. Novice A, Novice B, Advanced, Team, C Stream, etc.).

Overnight Accommodation: Possible hotels include Best Western Villager (park is directly behind) or Village Green Hotel (grassed walking area). It is not possible to camp overnight on site. A nearby camp site is Swan Lake RV Park & Campground at 7235 Old Kamloops Road.

Barn Etiquette: As this is a working barn and horses are about, dogs **MUST BE ON LEASH AT ALL TIMES**. Please do not walk dogs in horse stall area or **DOWN THE DRIVEWAY**. On leash around the parking lot is ok. Please remember to pick up after your dogs. If they eliminate on or close to the manure pile it is fine to leave the deposit. Disregarding these requests may put our club at risk of eviction.

Spectators: Spectators are very welcome but please leave non-competing dogs at home or in vehicles (if weather is appropriate).

Dog Jump Heights

Please include your dog's jump height even if you are in a class with no jumping required (you may move up during the trial).

Heights are measured from the withers (highest part of shoulders to the ground).
