**DIRECTIONS TO THE SHOW:**

From St. John & Fredericton – Take exit 446 Moncton Center – Riverview – Go straight and follow road for approx. 7.5 km. Coliseum is on your left.

From Nova Scotia – Take Exit 454 – Mapleton Rd. At end of ramp turn left on Mapleton Rd (arrow Moncton) Go straight on Mapleton Rd until you reach Mountain Rd. Proceed through the lights here and continue straight until you come to Killam Dr. (appro. 3.7km). Turn right on Killam Dr and continue straight for approx 1 km. Coliseum is on your right.
