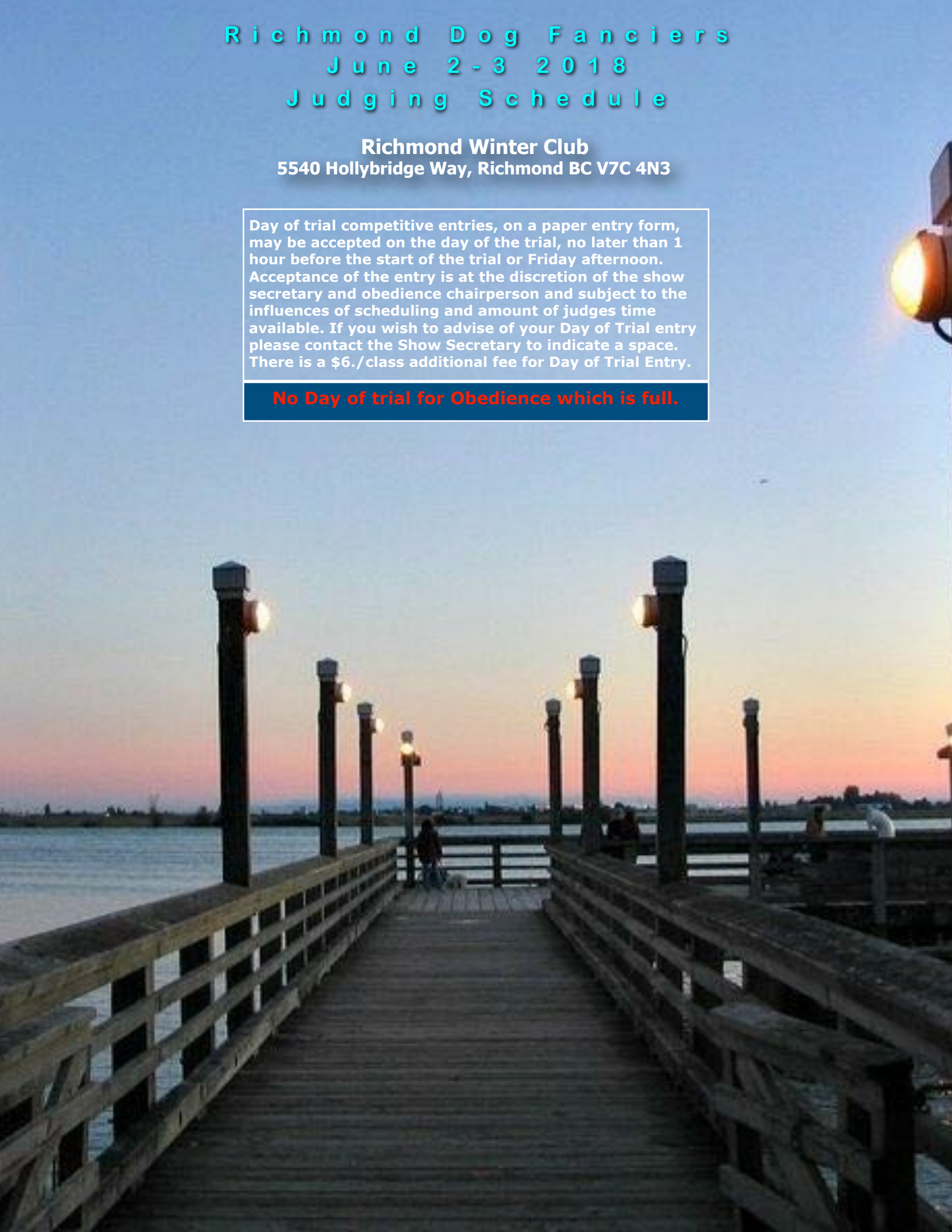

6.9 Moving Up

6.9.1 A dog that is registered in the records of the CKC with 38an eligible number according to these rules and has fulfilled the requirements for a title in accordance with these rules may be moved to the next level of competition if the schedule permits. The transfer must be on the appropriate move-up form and submitted to the trial secretary by the owner or handler at least 15 minutes before the start of the class.
