Attention Foreign Exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted. However, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no

To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and co-operation are appreciated. Thank you.

Entries must be submitted by mail, hand delivered or via the Entry Line. No other entry service is authorized to take entries for these events.

ENTRY INFORMATION

- All entries <u>must</u> be received by the closing date and time, accompanied by the proper fees and submitted on an OFFICIAL CKC ENTRY FORM. If more forms are required, please photocopy. Include postal code and telephone number. Please type or print clearly.
- Post-dated cheques will NOT be accepted, and all "NSF" cheques will be subject to a charge of \$25.00. All fees must be paid before the show. The SSKC does not accept credit cards.
- 3. The SSKC reserves the right to refuse any entry, subject to CKC rules.
- 4. Exhibitors must abide by errors made in entering their dogs, regardless of how the error was made or who made it.
- 5. Any overpayment of fees will be considered a contribution to our trophy fund.
- 6. To comply with CKC regulations, we will be unable to accept or substitute any entry reaching the Show/Trial Secretary after the closing time and date.

NON-MEMBER PARTICIPATION FEES ARE IN EFFECT

An annual "Non-member" participation fee for Awards and Titles will be charged to a Canadian "non member" of the Canadian Kennel Club. This fee will match the fee charged for Event Registration Number.

In order to protect the Awards and Titles earned, the "non-member" will have a choice to (a) either become a CKC member; or (b) pay the "non-member" participation fee. Failure to comply within 30 days of notification will cause All Awards and Titles to be cancelled.

Please Note: These fees only apply to dogs wholly owned by "Non-CKC" members and are not applicable to CKC members

OBEDIENCE EXHIBITORS PLEASE NOTE:

- 1. A separate entry form is required for Obedience trials (for each class)
- 2. Please designate jump height on entry forms.
- A bitch in season may not compete. Entry fees will be refunded <u>only</u> if a Veterinarian's Certificate to this effect is received by the Trial Secretary <u>before</u> the commencement of the Trial.

GENERAL INFORMATION

- 1. The building will be open at 7 a.m. with judging commencing at 8 a.m. unless entries warrant an earlier or later starting time. **Friday set-up is from 5-7 p.m.**
- 2. Only dogs entered in the Shows and Trials will be allowed in the building.
- 3. Dogs will not be allowed in the building overnight.
- 4. Prong or Spike collars will not be permitted at this venue.
- 5. Judging will proceed without any dog that is not present when called by the Ring Steward. Handlers and exhibitors with several breeds must arrange for alternate handlers should judging times conflict.
- All Group judging will begin on completion of Breed judging within each group. Best In Show, Best Puppy In Show, and Reserve Best In Show will follow all Group judging. Reserve Best In Show will immediately follow Best In Show.
- 7. The Superintendent will be in full charge of the Shows and Trials. To accommodate ALL exhibitors, the SSKC reserves the right to limit set-up space, size, and location of crates. Use of Ex-pens is not permitted. Your cooperation is greatly appreciated.
- 8. Dogs 3 months of age and under 6 months of age on the day of the show may be entered in Exhibition Only, providing that the owner of the puppies has also entered a dog in one of the regular Official Classes. No exhibitor may enter more than 2 puppies.
- 9. The SSKC will use all due care and diligence for the welfare of dogs and exhibitors but will not be responsible for, or assume liability in the event of, an accident or any misfortune to either dogs, exhibitors, or patrons and will not be responsible for equipment left on premises.
- 10. The SSKC greatly appreciates your co-operation in cleaning up after your dogs.
- 11. Section 19.7 Dog Show Rules: It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. It is the exhibitor's responsibility to know the rules pertaining to these events. A copy of these Rules is available from the Canadian Kennel Club.

CONFORMATION CLASSES

Baby Puppy A dog 3 months up to 6 months on the day of the show Junior Puppy A dog 6 months up to 9 months on the day of the show

Senior Puppy A dog between 9 months and up to 12 months on the day of the show 12-18 Months A dog between 12 months and up to 18 months on the day of the show

Canadian Bred A dog which was born in Canada

Bred by Exhibitor A dog owned and handled by the breeder

Open Class A dog 6 months of age or older Specials Only Dogs who are Canadian Champions

Exhibition Only Dogs 6 months and over not in competition. Dogs 3 months of age and under 6 months of age on the day of the show may be entered in Exhibition Only providing that the owner of the puppies has also entered a dog in one of the regular official classes. No exhibitor may enter more than 2 puppies.

OBEDIENCE CLASSES

Novice A & B, Open A & B, Utility A & B (Pre-Novice, Novice C and Novice Intermediate) SEPARATE ENTRIES ARE REQUIRED FOR EACH CLASS ENTERED State Jump Heights

RALLY CLASSES:

Novice A & B, Intermediate, Advanced A & B, Excellent A & B Rally ring size is 40' by 50'.

Exhibitors are expected to know the rules and regulations for dog shows, obedience and rally trials. Booklets on dog show, obedience and rally trial rules are available from the c.k.c

CHAMPIONS AND CHAMPIONSHIP POINTS

The schedule to be employed in the determination of the number of points awarded WINNERS shall be as follows:

A dog awarded Winners which also places Best In Show at an All Breed Conformation Show shall be credited with 5 championship points inclusive of any points earned at the Breed and Group level. A dog may not be credited with more than 5 championship points in a single show.

EVENT REGISTRATION NUMBER (ERN)

All dogs which are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will require an Events Registration Number (ERN).

To obtain an ERN number, simply do the following:

- Send a photocopy of the dog's Registration Certificate reflecting current ownership: for example AKC Registration Certificate with a written request for an ERN number.
- Include with the above a cheque or money order in the amount currently required payable to the Canadian Kennel Club.
- 3. Ensure that you provide us with your full return address to enable the ERN number to be sent to you.
- Faxed requests will be accepted. Please indicate your Visa/MasterCard number expiry date, cardholder's name and signature.

This Event Registration Number MUST be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "Listed"; however, failure to apply for an ERN number within 30 days will result in cancellation of any wins, awards or scores.
