



Lethbridge and District Kennel Club 2024 CKC AGILITY TRIALS

Site Location: Perfect Pooches Dog Training & Grooming (grassed area)
92082 RR 224, Lethbridge County, Alberta

General Information

The agility ring is on grassed area and in a fully enclosed ring.

Set up and benching can start on **Friday after 5:00PM**. Benching must be least 20 feet from the marked agility ring.

There will be no concession on site. Fast food and/or stores are approximately 10 minutes from venue.

No vehicles will be allowed to be driven onto the field. Day tents will be permitted, there is very limited shade available. No overnight tenting will be allowed.

For those with RV trailers, please find a LDKC member to assist you with where to park. Please clean up after your dogs.

There may be no leash runners during the trial. Please ensure you plan ahead and have a second leash available at the finish gate for the end of your run; or the leash may be carried during the run with the proviso that it is fully concealed.

**** WE NEED YOUR HELP** agility trials cannot run without volunteers. To make our trial run smoothly we would appreciate if you could participate when not running a dog. A Volunteer Sign-Up sheet will be available. There will be random volunteer draws for prizes throughout the weekend.
