ENTRY CLOSING DATE	8:00 p.m. October 1, 2017 or when entry limit is reached, whichever comes first.					
ENTRY FEE	\$60.00 per dog for one official test (DD). Listing fees are \$9.60. A listing fee is payable for all dogs entered that do not have a C.K.C. Registration number or a PEN/ ERN. Cheques should be made payable to SEOR-NDCC in Canadian funds. Personal cheques will be accepted. Returned cheques do not constitute a valid entry fee. NSF cheques are subject to a \$25.00 service fee. All entry fees listed include HST. Since U.S. cheques marked "Payable in Canadian funds" or "At Par" will not be cleared by Canadian banks, we require bank drafts or money orders payable in Canadian funds. No refund will be given.

JUDGING	Unless otherwise notified: Judging will start at 10:00 a.m. with the Control Exercises of the DD level. Equipment check will commence at 9:30 a.m.					
AWARDS	A rosette will be awarded for each qualifying score. The South Eastern Ontario Region of the Newfoundland Dog Club of Canada will present a medallion to each Newfoundland dog that obtains 3 qualifying scores at the test					
MEALS	There are no commercial facilities; we recommend that you bring your own. The Test Committee will supply coffee and doughnuts in the early morning.					
CLOTHING	Be prepared for any weather. This event is entirely outdoors and there is no provision for cover in the case of inclement weather					
CAMPING/ ACCOMMODATIONS	Not available at the test site, but is available nearby.					
DIRECTIONS	Please see the attached directions to the test site.					
GROUP OPTION	The Group Option as stated in Section 11.2 is not offered at this test					
BITCHES IN SEASON	Bitches in season are allowed to compete, but will be judged after all other entrants have been tested. These bitches must be kept away from the test site prior to being tested.					
REQUALIFICATIONS	Requalifications are accepted pending 'space available'. Re-qualifications shall be judged as the last team in the section for which they are entered					
SECTION 17.7 INDIGNITIES	Section 17.7 of the Draft Dog Test Rules and Regulations states: It shall be the duty and obligation of the test-giving club to see that a judge, club official, steward, volunteer or competitor at a Draft Dog test is not subject to indignities. The Draft Dog Test Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.					
SEOR LEASH POLICY	See Attached					



Leash Policy

- 1. All dogs at all SEOR events including; seminars, demonstrations, carting event (rides or Christmas tree pulls), parades, Water Rescue Dog tests and Draft Dog tests must be on a maximum six foot leash held by a competent handler at all times.
- 2. Exceptions to the above are; when participating in a training seminar, demonstration or a Water Rescue Dog or Draft Dog test where instructed by an Instructor, Steward, Presiding Judge or Event Chairperson to remove, lengthen or change the leash. The dog must be promptly re-leashed at the completion of any of the above or when instructed to do so by those mentioned above.
- 3. All dogs at an SEOR event not on a leash attached to a fixed object (such as a tree) or held by a competent handler, must be contained securely in a well ventilated vehicle or a crate suited for the dogs size so as not to run at large when unattended.
- 4. A brief announcement regarding this policy shall be made by the event chairperson at the beginning of each and all events held by SEOR.
- 5. Any handler that must be asked more than one time to leash or contain their dog may be banned from the current event by the Event Chairperson with the full support of the SEOR Executive.



**** Proceed North on Hwy 7A (Hwy 7A becomes Hwy 7 West) to Fowlers Corners. Turn right at the traffic lights at Fowlers Corners. Proceed easterly to another set of lights at a "T" junction (Chemong Rd). Turn Left and travel through Bridgenorth. Keep going on County Rd 18 to a 4-way stop at Buckhorn Rd (County Rd 23). Turn Left. Just past Lakefield Auto Wrecker (about 1km on LHS) we are the second house on top of the hill, 1450 Buckhorn Rd.
