Poop baggies as well as scoops and garbage cans will be easily available and we will have "spotters" making sure the regulations are being followed.

Those not cleaning up after their dogs will be fined under the City By-Laws and may find themselves banned from further participation in NKC events

BY-LAW NO. 1514

5. (1) When a Dog or Cat defecates on any public or private property other than the property of its Owner, the Owner shall cause such faeces to be removed immediately.

BY-LAW NO. 1382

3. No person shall obstruct, litter or befoul any street, sidewalk or public place in the City of St. John's with any refuse, debris, litter, garbage or any unsanitary, offensive or injurious substance or article of any kind in the City of St. John's

6. Any person who contravenes the provisions of this By-Law shall be guilty of an offence and liable upon summary conviction to a penalty as provided for in Section 403 of the City of St. John's Act, or where a violation notice is issued, to a penalty as provided for in Section 403.2 of the City of St. John's Act.
