**DIRECTIONS TO THE SHOW:**

**From Moncton/Nova Scotia:** Take Route 2 to Fredericton. From Fredericton take Route 101 to Fredericton Junction Turn left onto Prides Landing Rd. The Tri-County Complex will be on the left

**From Quebec/Ontario** – at the Quebec/NB border you are on Route 2, continue to Fredericton. From Fredericton Take Route 101 to Fredericton Junction. Turn left onto Prides Landing Rd. The Tri-County Complex will be on the left.

**US Exhibitors:** Traveling on 1-95 from the Houlton Border to Fredericton- Stay on I-95N entering Canada (NB). Continue on NB 95N taking Exit Ramp NB 2 East. Travel NB 2 East until you get to Fredericton. From Fredericton take Route 101 to Fredericton Junction. Turn left onto Prides Landing Rd. The Tri-County Complex will be on the left.

**From St John:** (Hwy 7) Immediately after Welsford Irving Gas Station, Turn Left onto Hwy 101, follow directions to Fredericton Junction. Turn Right onto Prides Landing Road. Tri County Complex will be on your left.
