It is not the responsibility of the ring steward to locate dogs. **Judges will not wait for any dog or handler delaying a class.** The figures following the Breeds indicate the number of dogs entered in - (1) Male Classes, (2) Female Classes, (3), Total in Breed

- Time for Conformation Judging is based on 12 dogs/hour
- Group judging will follow **immediately** upon completion of the breed judging within each group.
